Greater Fox Cities Chapter of Credit Unions 2025 Scholarship Contest Rules

All entries must be received by mail (postmarked by March 31, 2025), email, fax or dropped off in-person by <u>March 31, 2025</u>, and must follow all contest rules. The following documents must be submitted as part of this application:

- Completed Entry Form
- Typed Essay
- One or Two Typed Community Involvement Paragraphs

The essay and paragraph(s) on community involvement must be an original work of the applicant and should reflect subjects within the general scope of the essay questions. The essay and paragraph(s) must be typed. The essay cannot be less than 350 words or more than 500 words in length.

Applicant must be a graduating high school senior, attending a two- or four-year accredited educational institution in the fall of 2025, and an active member of one of the following credit unions:

The applicant must hold an account, in their name, at one of the above credit unions by January 31, 2025.

Members of the Scholarship Award Committee and their families are not eligible.

The Scholarship Award Committee will consist of employees selected from the above participating credit unions. Winners are chosen based on the criteria outlined on the front page of this application. All decisions are final.

All entries are subject to disqualification if they do not meet the above rules and requirements. School and membership requirements will be verified before selection.

Entries must be received or postmarked by the required deadline. Entries <u>received</u> or <u>postmarked</u> after the required deadline will not be eligible for consideration.

Winners will be notified by <u>April 11, 2025</u>, and scholarships will be presented during the Greater Fox Cities Chapter of Credit Unions chapter meeting on <u>April 21, 2025</u>.
