6.1 Item: 25-001 – Approve AB 1200 Administrative Assistant & Grant Coordinator

Discussion: AB1200 was created because of the need to ensure that local educational agencies throughout California adequately prepare to meet their financial obligations. The law requires districts to do multi-year financial projections, identify sources of funding for substantial cost increases, such as employee raises, hires/terminations, and make public the cost implications of such increases before approving employee contracts.

Recommended Action: Approve the Public Disclosure to create the Administrative Assistant & Grant Coordinator position and change to the Classified Confidential Salary schedule.
