Mortensen presented on PLC training. She would like to take four administrators and six teachers to San Antonio Texas this summer for PLC training. The training will train these 10 on how to come back and teach others how to teach with Professional Learning. She has taken teachers to this in other districts, and they saw great improvement in testing scores. This training will cost the district about \$25,000, funds have been found in ESSER Funding.

Watertown Rebels – Chris Renmoe was at the board meeting to ask any questions on the Rebels coming to town this summer. There will be six home games with a potential of nine this summer. They will provide their own liability insurance. They told Mortensen they would be willing to do the concession stands, unless we had someone else that wants to do them, Redfield Football Team has taken them. They can also provide the chain runners, however, they have to be over 10 years old.

Stand for the Silent – Falk admitted she should have sent something out in advance telling parents what Stand for the Silent was. Piehl mentioned that that presentation was more than likely the first time kids ever heard of suicide. Appel had also stated that we definitely need to talk about bullying in our school districts since there has been such a rise, however, the presentation should have had two groups with one much less graphic for the younger kids. Dr. Jungwirth and the student advocates are available for any student who may need to talk to them.
