School Data Presentation – Mr. Lewis and Miss Becker discussed test scores among their students. Both showed numbers of improvement from Fall testing to Winter Testing.

Mrs. Stover provided the Special Services Director report. She mentioned there have been a lot of meetings this month. She recently went to Pierre and sat in on the Legislative session. Miss Becker and her recently went to NSU for their job fair. She is currently looking for a Sped Director and Sped Teacher.

Mr. Lewis provided the Elementary report. PBIS had their assembly on perseverance and the 100<sup>th</sup> day of school was last week. He had three students attend honors choir las Friday. Mr. Tebben was in elementary classes and practiced 911 calls with the elementary students.

Ms. Becker provided the Middle School/High School report. Acolymics was in Fort Pierre last week. The students did great and brought home 5<sup>th</sup> place. She discussed possibly hosting an event here next year to get this area more involved. Teachers and students dressed up last week for I Hate Winter Week.

Mr. Seiler provided the Superintendent report. He stated Representative Johnson is coming to speak to our students on March  $21^{st}$ . At this time he will speak with both Elementary and High School Students. He will find out if this will be open to the public or not. He will be attending his national superintendent conference from February 16 – February 21. He also said legislative session is still in session, however, we should start looking at negotiations soon. Final candidates for the Elementary Principal position have been narrowed down, and Interviews will be held February  $22 - 25^{th}$ . He has also had a few companies come look at the football lighting. They will get estimates to us soon and we will discuss later if we should move on replacing them or not.
