Action #152 – Motion by Hodges, second by Wurtz to approve a cash transfer from the Capital Outlay Fund to the General Fund of \$440,000.00 using Capital Outlay flexibility. Chairman Esser called for a Roll Call Vote: Dickhaut – Yes, Hodges – Yes, Lambert – Yes, Wurtz - Yes; Motion carried.

Action #153 – Motion by Wurtz, second by Hodges to approve the renewal of Workers Compensation Insurance with Associated School Boards of South Dakota for 2020-21. Chairman Esser called for a Roll Call Vote: Dickhaut – Yes, Hodges – Yes, Lambert – Yes, Wurtz - Yes; Motion carried.

Mr. Seiler provided a construction update. He mentioned that grass has been planted and progress is being made on the weight room expansion. Mr. Seiler presented a proposal of \$12,800 for sprinklers from Inman Irrigation. He also discussed the low spot in the road on the south side of the school, including the fact that he is trying to get an estimate on the repair cost and options on how to proceed.

Mr. Seiler provided the Superintendent report. He provided an overview of guidelines in the State's "Back to Normal" plan related to school activities for the summer. He stated that priority would be given to fall activities for using the facilities, locker rooms would remain closed, and that there would be a limit on the number of students at one time. He also mentioned additional thermometers have been ordered to monitor students and coaches as they come into the building or on the field for practices.
