Father Tom discussed properties that the Church has purchased and possible arrangements with the school that could be mutually beneficial to address parking issues.

Action # 160 – Motion by Dickhaut, second by J.Esser to declare supplies/equipment (old fountain pop machine and canisters) as surplus. Motion carried.

Action #161 – Motion by Dickhaut, second by Hodges to accept the resignation of Ashley Badenhorst (Paraprofessional). Motion carried.

Action #162 – Motion by J.Esser, second by Hodges to approve Board Policies AA (School District Legal Status), ABAA (Redfield Public School Parent Involvement), AGA (Contested Hearings), and AH (Conflict of Interest Disclosure and Authorization). Motion carried.

Action #163 – Motion by J.Esser, second by Hodges to rescind Board Policy ABAB (Redfield Public School Complaint Policy for Federal Funds). Motion carried.

Action #164 – Motion by Hodges, second by J.Esser to table discussion and action on Agenda Item #12 (Intent to Rehire Administrators) until after Executive Session. Motion carried.

Mr. Storley provided a brief construction update. He noted that the next construction meeting would be held on February 12th.

Action #165 – Motion by J.Esser, second by Dickhaut to approve RFP #60 as presented and add the cost of the dividing curtain in the auxiliary gym. Board Chair Jordan called for a roll call vote: Yes – Jordan, J.Esser, Dickhaut; No – Hodges. Motion carried.

Mr. Lewis provided his Elementary Report. He discussed plans for the new playground, I Hate Winter Week activities, the fundraiser for Trevor Frost, Customized Learning meetings, and curriculum review. He also noted that Kindergarten screenings would be held on March 1st, PK-5 Parent-Teacher Conferences on March 4th, and Title I Night on March 11th.

Ms. Becker provided her Middle School/High School Report. She discussed PBIS meetings and incentives for attendance. She also discussed meetings with specific subject areas focused on student achievement and noted that a \$400 donation was received from the Community Memorial Hospital for water bottles for students.

Mrs. Stover provided a report on the December Special Education Student Count.

Mr. Storley provided his Superintendent's Report. He discussed the upcoming teacher job fairs, school board member terms, and provided a legislative update.
