# Trustee Hobbs moved, seconded by Trustee Brazley to approve the tenure denial and termination resolution as written below

**WHEREAS**, on September 20, 2012, the Board of Education ("Board") for the Hempstead Union Free Public School District ("School District") rejected the recommendation of the Superintendent of the School District ("Superintendent") to grant tenure to Robert Geras ("Geras"); and

WHEREAS, the September 20, 2012 vote of the Board was advisory; and

**WHEREAS**, on September 21, 2012 the Board gave Notice to Geras, pursuant to N.Y. Education Law §3031(b), that scheduled a special meeting to be held on October 25, 2012, for the Board to (1) finally

consider the Superintendent's recommendation that the Board grant Geras tenure and the Board's advisory decision to reject such recommendation and deny Geras tenure by a majority vote of the Bard, and (2) render a final decision; and

**WHEREAS**, on September 22, 2012 the Board placed Geras on an Administrative Leave of Absence with pay; and

**WHEREAS**, on September 25, 2012 the Board gave Notice to Geras, pursuant to N.Y. Education Law §3031(b), that the special meeting of the Board that had been scheduled to be held on October 25, 2012 was being **RESCHEDULED** for October 29, 2012; and

**WHEREAS**, the special Board meeting that had been scheduled for October 29, 2012 was rescheduled due to Hurricane Sandy, which made landfall that night and caused extensive damage to New York generally, and Long Island particularly; and

WHEREAS, the October 29, 2012 meeting for the Board to finally consider the Superintendent's recommendation that the Board grant Geras tenure, and to render a final decision, was further **RESCHEDULED** for November 7, 2012 and finally **RESCHEDULED** for November 12, 2012, and Greras having received notices of each rescheduled meeting, the Board proceeded this evening to hold a special meeting for the Board to finally consider the Superintendent's recommendation that the Board grant Geras tenure, and to render a final decision; and

**WHEREAS**, on September 28, 2012 Geras exercised his rights pursuant to N.Y Education Law §3031(b) and requested that the School District furnish him a written statement giving the Board's reasons for denying him tenure; and

**WHEREAS**, on October 5, 2012, the School District responded to Geras' exercise of his N.Y. Education Law §3031(b) rights and provided his with a written statement providing him with the Board's reasons for denying him tenure; and

**WHEREAS**, on October 17, 2012, Geras responded to the Schools District's October 5, 2012 written statement with his own rebuttal of the allegations in the Schools District's October 5, 2012 statement;

NOW THEREFORE, the Board having fully considered Geras' October 17, 2012 rebuttal, it is

**RESOLVED,** that the Board of Education, at a special meeting of the Board, on November 12, 2012, pursuant to N.Y. Education Law §3031(b), rejects the recommendation of the Superintendent to grant Robert Geras tenure and has made a final decision to terminate Robert Geras' employment with the School District effective 11:50 p.m. on November 12, 2012
