 - (1) Reviewed the Notice of Amended Charges and Specifications, dated October 15, 2018, the Amended Charges and Specifications dated October 15, 2018, and the exhibits attached thereto, and the further documentary evidence gathered in the investigation of the matters assigned to labor counsel for inquiry (hereinafter, collectively, the "Amended Charges and Specifications"); and
 - (2) Deliberated upon the Amended Charges and Specifications presented in Executive Session, as required by the terms of that certain Employment Agreement dated May 11, 2017 between the District and Employee # 4622 (hereinafter the "Employment Agreement"); and
 - (3) Discussed the merits of the Amended Charges and Specifications and found substantial and credible evidence to support the Amended Charges and Specifications against Employee # 4622; and
 - (4) Found good cause and sufficient proof exists to support the Amended Charges and Specifications; and
 - (5) Met to cast a "VOTE" as required by the terms of the Employment Agreement between the District and Employee # 4622,

does hereby adopt and approve the Amended Charges and Specifications to be preferred against Employee # 4622; and it is further:

RESOLVED, that the Board does hereby "VOTE," within the meaning of ¶10 of the Employment Agreement, and as required by ¶10 of the Employment Agreement, and as may be required by other applicable terms of the Employment Agreement, if any, and does hereby adopt and prefer the Amended Charges and Specifications against Employee # 4622; and it is further:

RESOLVED, the Board authorizes the Board President to execute the Amended Charges and Specifications, and directs Labor Counsel to serve the Amended Charges and Specifications upon Employee #4622 forthwith.

Resolution for Hempstead School District to file School Funding Complaint

2. WHEREAS, the manner in which New York State has funded the Foundation Aid formula, created in the wake of the Campaign for Fiscal Equity case, violates Title VI of the Civil Rights Act, which prohibits discrimination on the basis of race by any program that receives federal funding; and WHEREAS, the manner in which New York State has funded the Foundation Aid formula since 2008 has resulted in gross inequality, where, statistically-speaking, the higher the percentage of students of

color in the district, the lower the likelihood that the district is being funded at the level promised by New York State; and

WHEREAS, the <u>Hempstead</u> School District has previously suffered and is currently suffering from the results of this inequitable funding system; therefore

BE IT RESOLVED, that the Board of Education of the <u>Hempstead</u> School District, hereby authorizes the law firm of Bond, Schoeneck & King, PLLC ("Legal Counsel") to take the necessary measures to file a complaint with the U.S. Department of Education, Office for Civil Rights (the "Complaint"), against the State of New York, New York State Legislature, Governor of the State of New York, the New York State Department of Education, and/or other respondents deemed necessary by Legal Counsel; and

BE IT RESOLVED, that Legal Counsel shall be compensated for the above-mentioned services at a flat-rate fee of \$4,000.00 (four thousand dollars), and no additional costs or fees shall be expended by the Board of Education for such services pursuant to this resolution, and no additional services shall be performed by Legal Counsel other than the drafting and filing of the Complaint pursuant to this resolution, and the Board of Education hereby authorizes the Board President to execute a written agreement with Legal Counsel pursuant to the above-mentioned terms.

Resolution for Hempstead School District to join SSFC

3. **BE IT RESOLVED**, that the Board of Education of the <u>Hempstead</u> School District hereby authorizes the Superintendent to take the necessary actions for the District to join the Statewide School Finance Consortium ("SSFC"), an alliance of more than 420 school districts dedicated to securing fair and predictable funding for New York State's public schools, with the understanding that SSFC will be helpful in supplying the statistical data necessary for Legal Counsel to file a complaint with the U.S. Department of Education, Office for Civil Rights regarding inequitable Foundation Aid funding, and the Board of Education further authorizes the Superintendent to submit membership dues to SSFC for the 2018-2019 membership year not to exceed \$625.

Resolution for Hempstead School District to Sign an Open Letter and Participate in a Press Conference

4. BE IT RESOLVED, the Board of Education of the **Hempstead** School District hereby authorizes the Board President to sign an open letter to its State representatives, along with other school districts, regarding the inequitable funding of school districts including Hempstead; and

BE IT RESOLVED, the Board of Education of the **Hempstead** School District hereby authorizes the board, collectively, or through individual board members, to participate in a press conference, which is tentatively scheduled to be held in late October 2018, in support of the fight for equitable school funding for the children of our school district.
