UPSEU MEMORANDUM OF AGREEMENT

 WHEREAS, the District and the United Public Service Employees Union ("UPSEU" or the "Union") entered into a collective bargaining agreement on May 12, 2015 (the "CBA"); and

WHEREAS, there has been a dispute between the District and the UPSEU relating to the payment of health insurance buy back for certain employees dating back to January 2015, which resulted in an advisory opinion by an arbitrator pursuant to the parties' collective bargaining agreement's grievance machinery; and

WHEREAS, the UPSEU has commenced a special proceeding pursuant to CPLR Article 78 in New York State Supreme Court, Nassau County, i.e., Kevin E. Boyle, Jr., as President of United Public Service Employees Union v. Board of Education of the Hempstead Union Free School District, Index No 617492/2019 (Sup. Ct., Nassau Cnty) seeking an Order directing the Board to make the health insurance buy back payments to the affected employees in conformance with the Arbitration Award; and

WHEREAS, the District now seeks to resolve the matter with the UPSEU and it is therefore hereby

RESOLVED, the Board approves the settlement agreement between the District and the UPSEU to resolve the issue relating to payment of health insurance buy back for certain employees dating back to January 2015; and it is further

RESOLVED, the Board authorizes the Board President to execute the settlement agreement between the District and the UPSEU
