WHEREAS, the Board of Education of the Hempstead Union Free School District ("Board") is the duly constituted governance body of the School District; and

WHEREAS, Trustee Carmen Ayala is a member of the Board and bound by the District Policy and legal requirements that confidential information acquired in executive session shall not be disclosed and disclosure of same is a violation of General Municipal Law Section 805-a(1)(b) and the Hempstead Union Free School District Code of Ethics and policies; and

WHEREAS, the Board has been advised that there is reasonable suspicion that Trustee Carmen Ayala violated General Municipal Law Section 805-a(1)(b); the Hempstead Union Free School District Code of Ethics and policies and the Commissioner of Education Decisions and her duty of confidentiality and disclosed confidential information to a third party who is not on the Board of Education and was not in executive session; and

WHEREAS, the confidential information pertained to internal discussions of the school board members that occurred in executive session relating to personnel matter; and

WHEREAS, that there is reasonable suspicion that Trustee Ayala disclosed internal discussions and confidential information held in executive session in violation of her duty as a Board Member of the Hempstead Union Free School District; and

WHEREAS, the remaining members of the Board of Education have consulted with Special Counsel or has had an opportunity to have consulted with Special Counsel on the legal options available to address this serious concern;

IT IS THEREFORE RESOLVED, that:

SPECIAL MEETING MARCH 23, 2021-MINUTES

- 1. The Board authorizes an action to seek removal of Trustee Carmen Ayala from the Hempstead Union Free School District Board of Education pursuant to Education Law 1709(18) and District Policy of her official misconduct.
- 2. The written charges dated March 23, 2021 are hereby approved and preferred against Trustee Carmen Ayala and the Board is authorized to conduct a hearing on April 12 & 13, 2021 at 5:00 P.M. for said matter.
- 3. Pursuant to its authority, on February 17, 2021 the Board of Education designated James Clark, Esq., as hearing officer for said removal proceedings and authorized him to report to the Board of Education such findings and conclusions of law for a final determination by the Board of Education.
