Monthly Programme Fees

Fees are payable for all 12 months (August-July)*. **To qualify for subsidised rates, students must have a valid CPR registration by September 1st, 2025**.** Late or missing CPR registration will result in non-subsidised fees (DKK 6,500) for the entire school year.

Important Notes

CPR Registration & Subsidies

To qualify for subsidised fees, students must meet these CPR registration deadlines:

- Most grades (Kindergarten to MYP 4 and DP1): 1st September 2025
- MYP 5 only: 1st December 2025

Late submissions or missing documentation will result in non-subsidised fees (6,500 DKK) for the entire school year, as the school can only apply for state funding once per academic year.

Pre-Kindergarten Special Conditions Pre-Kindergarten students will be invoiced at the subsidised rate of DKK 5,190 per month. However, this rate requires approval from the municipality, and confirmation that the student has been withdrawn from their previous daycare. If either requirement is not met, the fee will be retroactively adjusted to the non-subsidised rate of 6,500 DKK per month.

Direct Debit

Registration for Direct Debit payment is mandatory within three months of enrollment. Failure to register will result in a monthly administration fee of 500 DKK. Parents unable to set up Direct Debit should contact the school office to arrange alternative payment methods.

Late Payments

All school fees are due by the first day of each month. The school will issue three payment reminders for outstanding fees. Continued non-payment for three months may result in the loss of the student's school place.

Withdrawal

Parents must provide three months' notice through the official withdrawal form. The final fee calculation depends on the submission date. Special withdrawal conditions apply during the re-enrollment period from February to August.

School Deposit

The deposit is refundable provided proper notice is given and all fees are settled. It may be used to cover the required notice period. For families not returning the following academic year, the deposit will be applied to cover July fees.

Fee Adjustments

Monthly programme fees and After School Care fees are subject to annual indexing with a minimum increase of 2%.
