

# ST. MARY CATHOLIC SCHOOLS WISCONSIN PARENTAL CHOICE PROGRAM Frequently asked Questions 2025-2026

#### What is the Wisconsin Parental Choice Program?

The Wisconsin Parental Choice Program (WPCP) allows students to attend a participating private school tuition-free if certain eligibility criteria are met and the students are selected by the Department of Public Instruction (DPI). The private school, on behalf of the student's parent or guardian, receives a state aid payment (grant) for each eligible student. WPCP is a separate application process from the St. Mary Catholic Schools (SMCS) tuition assistance application.

#### How do I know if we are eligible?

Families must meet income and student eligibility requirements.

Income eligibility: The prior year adjusted gross income (AGI) must be at or below 220% of the federal poverty guideline (see chart). This would include income of parents or legal guardians residing in the same household as the student applicant. Family size includes parents or legal guardians and their children by birth, marriage or adoption that reside in the same household as the student applicant.

Student eligibility: Students new to SMCS coming from a public school or home school in grades kindergarten through grade 12 are eligible.

Returning SMCS students and students new to SMCS from a private school entering 4K, kindergarten, grade 1 and grade 9 are eligible.

<sup>\*2023</sup> income can be used to qualify if you apply for the WPCP prior to filing 2023 taxes.

#### What expenses are covered by the WPCP grant?

The WPCP provides private schools with state aid that covers full tuition, registration, technology, required retreats and mandatory testing fees.

WPCP grants do NOT cover co-curricular activities, equipment, transportation, after-school or summer care, elective school trips, classroom supplies or meals.

#### How and when do we apply?

Parents must complete the online Private School Choice Program application during the open application period, **February 1-April 18, 2024** available at <a href="https://sms.dpi.wi.gov/ChoiceParent/">https://sms.dpi.wi.gov/ChoiceParent/</a>. An email address is required to apply. In addition, parents must provide supporting documentation directly to SMCS within the application period. **Applicants are strongly encouraged to call Shelley Wautlet prior to completing the application.** 

## What supporting documentation is required to complete the application?

<u>Proof of income</u> is required for all students new to WPCP. A signed copy of the federal 1040 is acceptable for verification. If taxes have not been filed, please contact Shelley Wautlet to determine the best option for you to qualify and provide documentation. *In most cases it is strongly recommended that you select the DPI method to verify income. The Department of Revenue (DOR) method is highly sensitive, and submissions are final. Do not enter your social security numbers until it is determined that this is the best method to verify your income.

<u>Proof of residency</u> is required for all new and returning applicants. For a complete list of acceptable forms, refer to the DPI website (see below). <i>All supporting documentation must be submitted to the SMCS business office during the application period.* 

#### How are students chosen to participate in WPCP at SMCS?

The DPI will randomly draw from all eligible applications. Parents are notified by the DPI via email in May/June regarding acceptance or waitlist status. The past 8 years, all SMCS students who were found eligible have been offered the grant, resulting in no waitlist at SMCS!

#### If we received a WPCP grant last year, do we need to reapply?

**Yes**, you must reapply <u>each year</u> online via the DPI website and supply residency documentation during the open application period. Students who have received a WPCP grant and reapply will be awarded the grant each subsequent year regardless of income and grade.
