

**SIDEBAR AGREEMENT  
BETWEEN  
WALL TOWNSHIP BOARD OF EDUCATION (BOARD)  
And  
WALL TOWNSHIP ADMINISTRATIVE AND SUPERVISORY COUNCIL  
(COUNCIL)**

**THIS SIDEBAR AGREEMENT** is made this 17 day of May 2022, is attached to, incorporated in, and made part of the existing Collective Bargaining Agreement (“Agreement”) between the **WALL TOWNSHIP BOARD OF EDUCATION** (“Board”) and the **WALL TOWNSHIP ADMINISTRATIVE AND SUPERVISORY COUNCIL** (“Council”).

**WHEREAS**, the Board and Council are parties to a Collective Bargaining Agreement (“CBA”) for the term of July 1, 2020 through June 30, 2023; and

**WHEREAS**, the CBA between the Board and Council is still in effect as of the date of this Agreement; and

**WHEREAS**, the Board seeks to provide Kevin Davis (“Mr. Davis”) and Tiffany Steiner (“Ms. Steiner”) with additional daily compensation for their service as Acting Principal(s);

**WHEREAS**, the terms set forth below contain the full agreement between the parties; and

**NOW, THEREFORE**, the Board and Council, in consideration of mutual covenants and promises contained herein, the legal sufficiency of which is hereby acknowledged, agree as follows:

1. Mr. Davis and Ms. Steiner will receive additional compensation at a rate of \$100 per day during the 2021-22 school year, ending June 30, 2022. Mr. Davis and Ms. Steiner shall be paid retroactively to begin with their respective start dates.

2. It is understood that the Council, Mr. Davis, and Ms. Steiner recognize this agreement will expire on June 30, 2022. If the need for the role of Acting Principal(s) beyond June 30, 2022 be warranted, another agreement will be necessary.

3. The parties agree that all other terms and conditions included in the CBA and not specifically referenced herein shall remain in full force and effect.

4. This Agreement contains the entire Agreement and understanding between the parties.

5. If a specific clause of this Side Bar Agreement is determined to be illegal or in violation of any Federal or State law, the remainder of the Side Bar Agreement shall not be affected by such a ruling and shall remain in full force and effect.



6. The parties shall be bound by the terms and conditions of this Side Bar Agreement.

7. The provisions of this Sidebar are subject to and contingent upon ratification by the parties represented by the signatories herein to the contract.

8. The parties have entered into this Side Bar Agreement freely and voluntarily.
