#### Survival of the FIT-test

Adaptation of new programs is always a big step in any city, state, or country. The same goes for the new FIT/WIT program that Liberty is just now starting to adopt. FIT/ WIT are small pieces of the giant SWSI (School Wide System of Intervention) program that is in place throughout California schools. They were initiated to help students that were struggling with their grades. Similar programs were attempted in California in 2004 and were implemented, but it was left to the schools' discretion on how they should be used. This same program was employed successfully in other places across the United States. Just last year,

Heritage High School put the "Patriots Plus" initiative into effect, a program with similar intentions to FIT/WIT. ". . . this is something that many schools around the state and nation are doing . . . . other schools may refer to it as RTI or another other name." explains school administrator Mr. Morris. The FIT program is especially polarizing across Liberty among teachers. "I think it's an excellent idea. . . . Scheduling time to take a breath, and catch up if need be is conducive to student success," savs Spanish II teacher Mr. Carey He is referring to FIT (Flex Intervention Time) which sets aside half an hour of each period every Thursday. This time would be reserved for individual work time

or one on one time with a teacher. Mrs. Einess, who was on the committee that instituted the new curriculum, says that it was implemented because of new legal obligations being pushed by the state government, but also by the teachers that want more individualized time to help students to succeed. Yet there is some concern that the new program will prove difficult to maintain because of already shortened class times being cut down even further. "I'm not that thrilled about it. I'm pretty possessive of my time with my students. When we switched to block and then A/B scheduling, we lost instructional time. So we are now going to lose more instructional time," comments history instructor Mrs. Bea-

ver. Because of the full half hour of class time that the FIT program takes away, AP classes have been excused from it due to the pacing of the classes. The WIT program, on the other hand, is not invasive to class time and takes place before school on PD Days. Mr. Morris explains that it is a way that teachers

can send two students to a detention-like program that their teacher refers them to. During this time, students can catch up on late work for teachers for full or partial credit. Both of the new pieces of school life here at Liberty have their pros and cons, but like them or not, they are here for the foreseeable future.

#### The true cost of magic Disney raises prices to record highs

It all started with a mouse. Just like the price of a magical ticket to Disneyland once started at one dollar, but times have definitely changed disneygoers everywhere. Disney raised their prices on October fourth, making tickets and annual pass prices an all-time high. One-day admission has gone from 96- 99 dollars within a six month time span. Annual passes have gone up by at most \$340, making the Premier pass (Disney World and Disneyland) \$1,439, the Signature Plus Pass (no blackout dates) \$1,049, and the Disney Signature Pass(350 days) \$849. Walt Disney chairman Bob Chapek shed some light on why the sudden increase was necessary. "We have to look at ways to spread out our attendance throughout the year so we can accommodate demand and avoid busting at the seams." According to the Orange County Register, single day prices have risen 140% since 2000, and 13% since the opening of Cars Land in 2012. It's also possible that the newly announced Star Wars Land has something to do with the sudden increase. Disney has provided reasons to justify the increase in prices, but that doesn't change how the decision will affect current passholders and Disney lovers in general. Liberty junior Hayli Greene added, "They're making it more and more difficult for the average family to visit Disneyland! It's sad!" Thousands of others have negatively commented on social media about the new Disneyland prices, but all have a common theme; they all plan on going back to the park regardless of the costly expenses.


# The right to die

Death with Dignity law passes in California

The hard truth is that we will face death one day; the difference is that some people's days will come naturally, while others will choose that day for themselves. There has recently been much talk about the Death with Dignity Law being passed in California. While the law has not been signed by the Governor as yet, it seems to be on its way. The Death with Dignity Law allows terminally ill patients to request a lethal medication that will kill them. In order to ensure patient safety, there are many rules placed around it. The rules that apply to the Death with Dignity law include: the patient being seen by two different doctors who both give them six months or less to live,

nal cancer, they must be eighteen years of age, and they must be able to take the medication themselves. If the patient meets all of these requirements, they may take part in this action in the states of Oregon, Washington, Vermont, and probably, soon, California. The Death with Dignity law was legalized because of a man named Dr. Jack Kevorkian, who took part in assisted suicide for terminally ill people. His first patient was a school teacher in Oregon, which started the discussion of legalizing this action. This eventually becoming the Death with Dignity Law, which first passed in Oregon in 1997. Dr. Jack Kevorkian willfully assisted many of terminally ill patients, about 130, end their lives.

Even though Dr. Jack Kevorkian is now deceased, due to liver cancer, his influence still remains. There is much controversy around this topic about whether or not it should be legal. While the doctor definitely had people appalled by his decision making, there were many people who supported him, which is a major reason why the law continues to be passed in additional states. A quote that opened up many people's eyes to the good that Dr. Kevorkian was taking part in was written by a prominent journalist in Michigan, Jack Lessenberry, and stated "Jack Kevorkian, faults and all, was a major force for good in this society. He forced us to pay attention to one of the biggest elephants in society's living room: the fact that today vast numbers of people are alive who would rather be dead, who have lives not worth living." Today this controversy remains, which is why the possibility of the law being passed in California has led to much discussion. For the meantime, patients who truly want to take part in this may relocate to one of the states in which the act is allowed and legally take their own lives.



#### Cancellation of CAHSEE causes curriculum changes

A recent change to the California High School Exit Examination (CAHSEE) system will now impact current sophomores in high school. As of now, students will no longer worry about meeting this certain requirement to graduate high school due to the recent cancellation of the exam. The cancellation of the exam is due to a test contract that expired with the Educational Testing Service. This contract was only enforced through the exam proctored in May. Hence, the exam destined to take place in July has been cancelled. As a result, the former state standards from the CAHSEE are no longer taught in classrooms. According to Pat Walsh, principal of Liberty High school, "Governor Brown recently signed legislation eliminating the CAHSEE in California. So,

there will be no more administrations of the CAHSEE in schools in our state." The exam had originally begun with the senior classes of 2006 in which students were provided with the opportunity to take the exam up to eight times during high school. Now, the CAHSEE will be suspended for three years as of 2016-2017 and 2018-2019 allowing a time to develop a graduation requirement that is adequate for the new Common Core Standards. Walsh ensures, "Our students no longer need to pass the CAHSEE in order to graduate." For some this may be the greatest of news, but it is

certain that the termination of such exam will cause major differences within classroom settings. According to the San Jose Mercury News, "More than 300 students from San Francisco and Oakland alone are affected." Although a plethora of students are affected, it is known that the system of the University of California has not seen a case in which a student is not accepted for failure to pass the CAHSEE. With the development of new Common Core Standards, teachers, parents, and students realize that the material tested on the CAHSEE reflects a curriculum that has not been utilized in California's schools for plenty of years. This signifies that fellow students have taken the exam with an outdated curriculum. Hence, it is about time the curriculum begins to develop further and eliminate testing students on standards that are no longer taught.



# School IDs do matter; here is why





# Working at nail salons: what are the risks?

Anyone who has had their nails done before knows the distinctive "nail salon" smell; it's hard to miss that wave of fumes greeting you at the door. While this kind of exposure isn't very threatening to weekend regulars or walk-ins, the nail technicians who actually handle the chemicals for hours every day could be at risk for serious health problems. Employee's most common complaints include inflammation of the eyes, nose, and throat, shortness of breath, nausea and coughing. While these concerns aren't too serious, there are studies showing a link to even more severe health aliments. Earlier this year, The New York Times published a series of articles revealing the hardships nail salon workers sometimes have to endure. including a piece purely dedicated to uncovering personal stories of employees and their experiences with the long term effects of chemical exposure. The article brought to light the common themes of miscarriages, birth defects, cancer and serious respiratory illnesses among nail technician. Two of the woman interviewed had experienced at least one miscarriage and had a child, or knew a fellow salon worker's child, with a birth defect or mental disorder. Eugenia Colon, a salon owner in Brooklyn, was diagnosed with sarcoidosis, an inflammatory disease. Once she saw the scan of her scarred lungs, her doctor explained to her that when she inhaled acrylic powder the tiny particles scratched the soft tissue of her lungs. Le Thi Lam, another nail technician, was part of a survey taken by the Cancer Prevention Institute of California and spoke about how she had developed a thyroid condition, and then eventually breast cancer. She was quoted

saying "I know that manicurists

like me are also going through the same things and having major health problems, but they still hang on to their jobs to earn their living." It's obvious that nail salon employees are suffering from an array of medical issues. Not only is that illustrated in the personal stories shared by workers, but scientific studies conducted by the Environmental Protection Agency (EPA) and the National Institution for Occupational Safety and Health (NIOSH) show results that help back up their statements. With all of this information out there accusing nail salon products of being toxic, one can only wonder why these chemicals are still being used. Well, the FDA doesn't have the right to approve cosmetics before they are sold and they do not have a list of required tests for any certain product or ingredient. There is, however, a list of illegal ingredients, but many of the potentially harmful chemicals, like dibutyl phthalate, toluene, and formaldehyde (also known as the "toxic trio"), still found in products are not banned. It is up to the cosmetic companies to manufacture safe products. Yet, the corporation's idea of "safe" differs from the worker's. Plus, there is no hard evidence proving these chemicals are directly linked to the health issues being reported; only research that suggests chemicals are "linked to" certain symptoms or sicknesses. All these loopholes allow for continuous production of cosmetics that may or may not be harmful. However, employees and employers can protect themselves by following safety protocols such as wearing gloves and masks, installing proper ventilation, keeping the door open, and using as many toxic free products as they can until a better solution can be found.

According to suicide.org a teen takes their own life every one hundred minutes. Suicide is the third leading cause of death for people ages 15 to 24 and only 30% of teens with depression are being treated. Psychologists believe that while genetics may be a factor, many other situations, such as chronic illness, trauma/abuse, being a part of the LGBT community, or having a lack of support may also cause depression. "These kids are at a higher risk for depression because they carry more stress on a day-to-day basis." Says psychiatrist, Meghan Fagundes. There are many stereotypes regarding someone who is depressed. People usually think of those with depression as sad people who wear black and cry all the time, but this is not always the case. Anyone can have depression, whether it is a person who wears black and cries all the time, or an all-star football player. "There is no single cause for

es may seem bleak, there are many treatment options. Common treatments are therapy, exercise (sports, yoga, etc.), meditation, support groups, medication, and even hospitalization. While these treatments usually do the trick, they don't always work. "Electroconvulsive therapy - or ECT - isn't usually used, but sometimes it is necessary. This is a last resort because it involves inducing seizures to 'reset' your brain, which causes memory loss." Explains Meghan Fagundes. Do you have a friend who is depressed? Many symptoms of depression may not be obvious, but little things like loss of motivation or increased irritability can be signs that there is something wrong. If you notice any of these things, reach out. Depression is like having a broken bone; it can't just be fixed by telling it to "try harder" or to "cheer up". In order to heal, a person needs constant support. If you don't know how to help, talk to an adult or someone who knows what they're doing. If you know someone who is depressed or considering suicide, don't hesidepression; everyone is differ-ent." Says councilor, Ms. Bigler. 

#### Student athletes must balance academic and athletic life

Hours of practice, months of training, years of commitment and a few moments to do homework, this is a typical schedule for a high school athlete at Liberty. High school athletes spend hundreds of hours training and practicing for games but they aren't assigned time to do their homework and study for tests. Coach Walters, varsity football coach at Liberty shared the routine that the football team has to participate in daily in order to compete. After school the football players must lift weights for 45 minutes, then the special teams kick for 15 minutes. After that, there is a 55 minute offense training then a 55 minute defense training. Finally, the practice concludes with 10 minutes of conditioning "On average a football practice lasts about 3 hours." Coach Walters explains. Since a normal practice would end around 6:30, it will still take time for athletes to get home, clean themselves up from a long practice and eat their dinner. After all of this time is consumed on a school night, when will they have time to do their homework? Zakk Lowe, wide receiver on the varsity football team explained that keeping his grades up motivates him to be better because it restricts his time, which adds a challenge. The senior has an accumulative GPA of a 3.91 which is above the requirements the school asks for all student athletes. "District policy mandates a minimum of a 2.0 GPA to participate in athletics. We ask our players to do their best and strive for a program GPA above 3.0 - which we accomplished this year." according

to Coach Walters. Although ath-

letes have little time after school to complete their assignments and prepare for their upcoming classes, they are given the opportunity to change that. "We have a mandatory study hall period in the morning in the Library where we monitor the football player's grades and get them help if need be." The method of having a morning study hall has helped athletes because it is a time for them to sit in and really focus, but not all sports have opportunities like this, only football. Kai Bohannon, student athlete, explains that she isn't given any extra opportunities to help with her grades. Kai runs cross country, track and plays basketball, which means that she is a year round athlete, which makes keeping up grades a harder challenge. The junior at Liberty is glad to say she has an accumulative GPA of a 4.06, which she explains, "I always manage my time, I can't ever procrastinate!" Although sports leave students on a short amount of time to get their homework done, it is definitely achievable. "Yeah, playing a sport and taking advanced classes is difficult but it's also beneficial because I am able to work with my teammates on homework, ask them questions and study together." Furthermore, sports take up time and energy but they provide a challenge, which most athletes love, the challenge to balance time. Through multiple interviews, all athletes agree that keeping up their grades is a difficult challenge but it something looked high upon to complete. 
