


- 2 this contains the purpose of the Constitution
- 5 this clauses indicates how to resolve conflicts between state and federal laws
- 8 in this system of government power is divided between regional and central bodies
- 9 this court cases established the Supreme Court's right to declare an act of Congress unconstitutional
- 11 power and authority in our government come from this group
- 12 this term means that accused people get certain rights

- 18 the right of accused persons to be brought before a judge to hear the charges against them
- 19 according to this amendment, Congress may not declare an

- official religion and must allow citizens to practice their religion freely
- 20 The US legal system requires that people accused of crimes be informed of these

- 1 Article 1 in the Constitution provides for this branch of aovernment
- 3 this court case established that state laws that conflicted with federal laws are unconstitutional
- 4 if a state's population declined, they would get less representatives in this body. Also, this body can impeach
- 6 Congress can make all laws which are "necessary and proper" for carrying out its duties (what is it called?)
- 7 this amendment protects citizens against unlawful search and seizure
- 10 the right to do this has been granted to women, African Americans, the citizens of Washington DC and 18 year olds
- 13 the power of the president to veto a bill and send it back to Congress



- 1 the redrawing of voting districts is called this
- 7 this term refers to legistation the national government requires state or local governments to implement at their own expense
- 9 power to levy taxes is this type of power
- 10 this clause says that a state cannot discriminate against residents of other states or give its own residents special privileges.

- 16 inconsistencies from state to state are one of the downsides of this system
- 17 the goal of this is to restrict unrepresented minorities role in an organization

- 21 this form of city government combines democratic rule with professional expertise and is the most common in the US Ioday
- 22 this clause requires states to recognize, honor and enforce oneanother's public actions
- 23 the job of this person is to manage their state's executive branch

- 3 ths unit of government regulates water, schools, libraries parks and fire
- 4 In this case, the Supreme Court ruled that the Gun-Free School Zones Act was unconsitutional
- 5 in this case, the Supreme Court ruled that legislative apportionment is both a federal and state matter
- 6 According to the Constitution, the national government must guarantee that every state government has this type of structure
- 8 this group apportions seats, composes budgets and passes laws
- 11 usually, this group of people approve an amendment to the state constitution
- 13 in this system, voters elect city council members and a mayor
- 14 this policy both advocated by Nixon and Reagan was aimed at transferring power back to the states
- 15 drawing a legislative district to give one party an advantage
- 18 in this type of federalism, the roles of state and local are a chaotic mix because they include "grants-in-aid programs

- 2 Tinker vs. Des Moines dealt with this civil liberty
- 4 this landmark cases decided the use of public funds to support private religious schools was unconstitutional and established a three point test to determine if and when a government action violates the Establishment Clause
- 7 the phrase, "you have the right to remian silent" reflects the provision in the Bill of Rights regarding this
- 11 In this 2008 case, the Supreme Court struck down a law prohibiting the registration and possession of firearms
- 13 In this 1963 case, the court ruled that the sixth amendment guarantees legal counsel regardless of the defendant's ability to pay
- 14 this court case said that freedom of speech applied to the states
- 16 this amendment guarantees the privacy of people's homes
- 19 this guarantees the ability to practice whatever religion one chooses
- 20 this term refers to preventing publication of certain material

- 1 this amendment says that law enforcement officials must have a warrant before searching private property
- 3 orally speading false information about someone with intent to cause harm
- 5 this body interprets the Bill of Rights
- 6 this unpopular form of expression is protected by the first amendment
- 8 The process of applying the Bill of Rights to the states through Supreme Court decisions is called this
- 9 these are the basic freedoms considered to the be birthright of all individuals
- 10 guarantees of equal rights and equal treatment under the law such as trial by jury and voting rights
- 12 a decision by a court that serves as an example or guide for future decisions is called this
- 15 publiishing false information about someone with intent to cause harm
- 17 this amendment guarantees the right to bear arms
