1. Ntabwo hazabaho guhungabanya umutungo rusange. Ukwangiriza umutungo uko ariko ko kose bigomba kwishyurwa n' umuntu cyangwa itsinda ryabigizemo uruhare. There shall be no defacing of public property. Any damages to any property must be paid for by the individual or group responsible.
2. Abanyeshuri bagomba guhora bamenyesha buri gihe abantu bakuru b'abajyanama babo ibijyanye n'ibikorwa byabo n'aho bajya hose. Scholars shall keep their adult advisors always informed of their activities and whereabouts.
3. Abanyeshuri bagomba kwhiuta ndetse bakababiteguye ibikorwa byose. Scholars should be prompt and prepared for all activities.
4. Nta binyobwa bisindisha cyangwa ibiyobyabwenge mu buryo ubwo aribwo bwose bigomba gutungwa n'abanyeshuri igehe icyo aricyo cyose, uko byagenda kose. No alcoholic beverages or narcotics in any form shall be possessed by scholars at any time, under any circumstances.
5. Kunywa itabi cyangwa ibitumura imyotsi bizemerwa. No smoking or vaping will be permitted.
6. 7.
