8th Grade End of Year Activities Contract

November 20, 2024

Purpose:

The purpose of this contract is to outline the expectations for 8th-grade students regarding discipline, attendance, academics, and the maintenance of technology. Adherence to these expectations is essential for participation in the end-of-year activities, including but not limited to the 8th Grade Moving On Ceremony.

1. Discipline:

- Students are expected to follow school rules and demonstrate respectful behavior towards peers, teachers, and staff.
- Any disciplinary action (detentions, suspensions, etc.) may result in the loss of privileges related to end-of-year activities.
- Consistent positive behavior, including respect, responsibility, and fairness, is required.

2. Attendance:

- Students must maintain regular attendance and provide appropriate documentation for any absences.
- A maximum of 3 unexcused absences is allowed for participation in end-of-year activities.
- Students must be present on the day of ALL grade-level events (until 12:15 p.m.) to participate, including the Moving On Ceremony and 8th Grade Dance.

3. Academics:

- All students must maintain a passing grade of 71% or above in all subjects.
- Students with failing grades will be required to meet with teachers to develop a plan to improve before the end of the year.
- Completion of all assigned work and participation in classroom activities is mandatory.
