

**SECOND AMENDMENT TO CONTRACT
FOR TRANSPORTATION SERVICES**

This **SECOND AMENDMENT TO CONTRACT FOR TRANSPORTATION SERVICES** (the "Second Amendment") is entered into as of the 27th day of October, 2022 by and between the Consolidated School District of New Britain (the "District") and Specialty Transportation, Inc. (the "Contractor"). The District and the Contractor are collectively referred to as the "Parties".

RECITALS

WHEREAS, the District and the Contractor are Parties to a **CONTRACT FOR TRANSPORTATION SERVICES**, dated March 5, 2018, (the "Contract"), whereby the Contractor agrees to provide certain transportation services ("Transportation Services") to the District; and

WHEREAS, the term of the Contract commenced on July 1, 2018 continues through June 30, 2023 (the "Term"); and

WHEREAS, by an Amendment to Contract for Transportation Services (the "First Amendment"), dated May 7, 2020, Parties amended the Contract to reflect changes required for a limited period as a result of COVID-19 and Executive Order No. 7;

WHEREAS, by Memorandum of Understanding ("MOU"), last signed January 28, 2021, the Parties agreed to additional terms for the 2020-2021 School Year; and

WHEREAS, with this Second Amendment, the Parties desire to further amend the Contract as reflected herein. This Second Amendment, the First Amendment, and the original Contract will be referred to herein as the "Contract" and will constitute the entire agreement between the Parties.

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants contained herein, the Parties hereto agree as follows:

1. I. **TERM** - At the end of the sentence insert the following:

The **CONTRACTOR** will provide the transportation services set forth herein for an additional two (2) year period, beginning July 1, 2023 and continuing through June 30, 2025 (also, the "Term") for all students designated by the District, unless this Contract is terminated by the **District** earlier than June 30, 2025 in accordance with the terms of this Contract."

2. IV. **PAYMENT AND COMPENSATION** –Replace Exhibit A (attached hereto) for the Exhibit A attached to original Contract.


3. Delete the first two bullets of Section 2.2.2(f) of the Proposal Documents and replace with:
 - 30 passenger and larger buses: 7-year average with no bus older than 10 years;
 - Less than 30 passenger bus/vehicles: 7 year average with no bus/vehicle older than 10 years.
4. Section 8.17 of the Proposal Documents is modified to provide:

The District requires a Performance Bond equal to 100% of the 2023-2024 School Year's estimated Contract price.
5. In Section 8.24, subsection F.1 of the Proposal Documents, delete Kevin Kane, Chief Financial Officer and the corresponding email and replace with:

6. Miscellaneous
 - (a) Except as otherwise expressly provided by this Second Amendment, all of the respective terms, conditions and provisions of the Contract shall remain in full force and effect. It is declared and agreed by each of the parties hereto that this Second Amendment and the Contract be read and construed as one instrument.
 - (b) This Second Amendment may be executed and delivered in any number of counterparts, each of which shall constitute an original, but all of which when taken together shall constitute but one and the same Second Amendment.
 - (c) The provisions of this Second Amendment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
