March 13, 2023

Present were Mayor Gove, Chair, Kate Currie, Abigail Jurist Levy, Maryann Welch, Greg Noyes, and Elizabeth McAndrews.

- I. Call to Order/Moment of Silence/Mission Statement/Pledge of Allegiance (4:15)
- II. Comment by Visitors and Delegations (5:22)
 - Steve Stanganelli 12 Amidon Ave Mr. Stanganelli noted he was a city councilor in Amesbury, speaking in his own capacity. Mr. Stanganelli encouraged review of legal liabilities within the district and procedures for Medicaid reimbursement.
 - (Facebook Comment) Public comment Cynthia Collins pearl street. How is the Federal case worked into the budget and what did that cost? Including attorney cost and reimbursement to the family. Thank you Cindy.
- III. Communications & Reports (10:35)
 - Educational Leadership Superintendent McAndrews. The Superintendent shared a
 facilities update stating that the AHS fire panel is currently being repaired. The
 Superintendent also shared the findings from the district's Title IX self-audit. The
 committee discussed the findings from the audit and next steps.
 - 2. Student Advisory Council Ms. Yee updated the committee on current SAC projects including an update on the success of the recent winter carnival and planning for an end of year event.
 - 3. Liaisons
 - a. Mayor Gove updated the committee on the Shay Memorial project including updates on construction, ongoing technology and furniture installations, and the neighborhood meeting schedule. Superintendent McAndrews stated there is a high level of excitement to move into the building.
 - b. A letter from SEPAC was read into the record. The letter introduced the new SEPAC leaders and shared information on the Parents Night Out event.

The committee asked questions of the Superintendent relating to the proposed budget.
