





LDC Program Objectives

- Providing EPSOs to students/school systems in our service area
- Maintaining compliance with governing policies
- Reducing the amount of data entry required to track challenge exam completion
- Ensuring accuracy of data reporting



What's the Same

- Four Dual Credit courses :
 - BUSN 1300 Personal Finance
 - CITC 1308 Computer Literacy & Apps
 - COL 1010 College Success
 - PHED 2050 Health & Wellness
- Up to 12 credits awarded once student enrolls at JSCC
- Minimum score of 70 required

- Less data entry required





Local Dual Credit

Jackson State Community College partners with high schools within their 14 county service area to offer local dual credit opportunities in PHED 2050 Health and Wellness, BUSN 1300 Personal Finance, COL 1010 College Success, and CITC 1308 Computer Literacy. Additional local dual credit options may be available. Students have the opportunity to earn credit that may be applied at Jackson State. Faculty at the college train high school faculty on the learning objectives for each course and provide challenge exams to determine if credit may be awarded (minimum grade of 70 required). 
- Click Local Dual Credit Permission



- Schools will be sent Dual Credit testing invoices at the end of each term
- Billing dates: May 15th for Spring term; December 15th for Fall term
- Invoice due in 30 days
- Sample bills for each school will be provided

Final Thoughts

- JSCC Local Dual Credit pass rate: 60% (2021-2022)
- State Dual Credit pass rate: 6% (2021-2022)
- ALL students can begin at JSCC with up to 12 credits from LDC
- Students can **“save”** four of their DE grant courses for other dual enrollment classes
- More accurate reporting/capturing of LDC challenge exam data
- Less data entry from school partners required
- Online testing to begin Spring 2023; billing to begin Fall 2023 (December)
