- **Italian Year End Examination** are taken at an Italian School, please contact Italian Department for further information.
- **Compulsory Educational Trips** are not included in the Tuition Fees and are billed separately on demand.
- **Entrance Assessment Test** and SEN test are charged at € 300 payable in advance. These amounts will then be deducted from the registration fee if a place is confirmed.
- **Bus Service fees:** the school doesn't run the bus service directly; it's handled and charged by a third-party transportation company. Costs will be published on the school's website *before* the new school year begins.
- **Lunches** are *not* covered by tuition fees but billed separately. The current price is € 7,80 per lunch (excluding VAT). The school will publish any changes to the lunch cost on the website before the new academic year begins.

9. OVERDUE PAYMENTS

10. WITHDRAWAL FROM THE SCHOOL

Any withdrawal of a student from the school must be communicated to the Principal via his Secretary in advance by giving notice according to the following deadlines:
