## Information: A. FY24 Audit

Dr. Magalhaes introduced Meghan Hyland from Hague, Sahady & Co. to discuss the FY24 Audit.

Ms. Hyland reported the FY24 financial statements audit was completed with no findings and B-P was issued a clean audit report, the changes in the FY24 budget were expected due to the building construction, and the single audit will be complete by the March 31 deadline.

A question was asked and answered regarding the number of years Hague, Sahady has been auditing the District.

# Information: B. Construction Project - State Qualified Bonds

Dr. Magalhaes introduced Margaret MacLean from Unibank to discuss state qualified bonds.

Ms. MacLean explained the difference between issuing bonds under the state versus a district bond rating, there was an opposite effect on the bond market over the summer, and it would make sense to go with a state qualified bond to borrow the \$120 million. A vote will be needed in February.

# Information: C. Continuing Ed Report

Mrs. Shaw reported on the Continuing Ed program. She discussed B-P instructor led courses, Ed2Go courses, leased classroom space courses by Gould Construction and the Construction Supervisor Institute, marketing, recruitment, future opportunities, and revenue.

Dr. Magalhaes added that the program hopes to offer electives we previously held at B-P.
