AMESBURY SCHOOL COMMITTEE SCHOOL COMMITTEE MEETING MINUTES VIRTUAL MEETING

December 7, 2020

Present were Mayor Gove, Chair; Peter Hoyt, Mel Webster, Kate Currie, Abigail Jurist Levy, Maryann Welch, Elaine Bucher and Elizabeth McAndrews.

This meeting was conducted under the 'Executive Order Suspending Certain Provisions of the Open Meeting Law G.L. c.30A, §20', signed on March 12, 2020.

- I. Call to Order, Pledge of Allegiance and Mission Statement (0:44)
- II. Comments by Visitors and Delegations (3:00)
 - 1. Dr. Ricci and Superintendent McAndrews recognized the principal and Superintendent's award winners.
 - 2. Jen Donais and students who participated in STEM week presented to the committee.

- III. Executive Session (24:00)

Ms. Welch moved to enter executive session, seconded by Mr. Hoyt. Vote: Yes, unanimous.

- IV. Presentations and Administrative Reports (25:15)
 - A. Superintendent's Report Superintendent McAndrews and Dr. Ricci the rationale for modifying the community service requirements.

Mr. Hoyt moved to accept the proposed changes, seconded by Ms. Welch. Vote: Yes, unanimous.

The Superintendent also updated the committee on the plan for snow days during the 2020-2021 school year.

Mr. Webster moved to accept the Superintendent's recommendation for snow days/remote days, seconded by Ms. Bucher.

Mr. Webster rescinded his motion.

Mr. Webster moved to waive policy EBCD for the remained of the current school year and accept the Superintendent's plan as submitted, seconded by Ms. Currie. Vote: Yes, unanimous.

- B. Director of Finance Reports Joan Liporto updated the committee on the updated S. Hampton Tuition, transfers, and an AIHS van lease.
 - The following votes were taken: Mr. Webster moved to approve a 2.14% increase in the tuition rate for S. Hampton brining the new rate to \$13,334.96 and also that the committee would meet further to discuss future increases, second by Dr. Jurist Levy. Vote: Yes, unanimous; Mr. Hoyt moved to approve the transfers in the amount of \$99,147, seconded by Ms. Welch. Vote: Yes, unanimous; Mr. Webster moved to approve a 3 year lease for a van for the AIHS, seconded by Ms. Welch. Vote: Yes, unanimous.

C. Chair's Report – Mayor Gove updated the committee on the Superintendent search process. A discussion by the committee on appointing a search committee followed.

Mr. Hoyt moved to appoint Dr. Jurist Levy and Ms. Welch to the Superintendent Search Committee, seconded by Mr. Webster. Vote: Yes, unanimous.

Mayor Gove also shared an update on the goals developed by the committee during the MASC workshops. The committee discussed the goals and holding future workshops.

D. Policy Subcommittee Report – FF-E recommendation: Naming of new early educational facility.

Ms. Currie read the recommendations of the policy committee for the naming of the new elementary school. The committee discussed the report and options for naming the new school.

Mr. Hoyt moved to nominate the Sargent Jorden Shay Memorial elementary school for the new school building, second by Ms. Welch.

Ms. Welch moved to nominate the George E. McNeill elementary school for the name of the new school, seconded by Mr. Webster.

Discussion by the committee followed.

Mr. Hoyt rescinded his previous motion and offered a new motion to name the new school the Sargent Jordan Shay Memorial Lower Elementary School, seconded by Mr. Webster.

Ms. Welch rescinded her previous to motion and offered a new motions to name the new school the George E. McNeill Lower Elementary School, seconded by Ms. Bucher.

After input from Ms. Currie, Mr. Hoyt and Ms. Welch rescinded their motions. Ms. Curie then moved to nominate the Sargent Jordan Shay Memorial Lower Elementary School and George E. McNeill Lower Elementary School as names for consideration, second by Ms. Bucher. Vote: 5 Shay (Webster, Jurist Levy, Hoyt, Gove, Welch), 2 McNeill (Currie, Bucher). Shay is selected.
