## I. Amesbury Public Schools Reopening Plan (3:00)

- Superintendent Fulgoni gave a summary of the reopening plan and changes that were going to be presented.
- Principals Nolan and Mascia presented the changes to the AES & CES hybrid plan to the committee followed by general questions and discussion (7:30)
- Principal Gill presented the changes to the Middle School hybrid plan to the committee followed by general questions and discussion (49:15)
- Principal Maguire presented the changes to the AIHS hybrid plan to the committee followed by general questions and discussion (1:24:50)
- Principal McAndrews presented the changes to the AHS hybrid plan to the committee followed by general questions and discussion (1:37:30)
- Dr. Catarius updated the committee on the changes to the hybrid plan for special education students followed by general questions and discussion (2:12:45)
- Lyn Jacques updated the committee on the district's technology infrastructure followed by general questions and discussion (2:26:00)
- A general discussion on the plan as a whole took place, including ideas proposed by community members (2:39:35)
