- 2. Expenses Superintendent Fulgoni discussed ongoing expenses during the shutdown as part of his update on item #1 (savings).
- 3. Remote Learning School principals joined the committee to give an overview of what daily remote learning looks like in their schools during the school shutdown. Ms. Jacques shared district focus on data, scheduling, and technology.

- 4. Special Ed Dr. Catarius gave an update to the committee on the ongoing Special Education operations during the school closure.
- 5. Communication Superintendent Fulgoni and school administrative staff provided updates to the committee on ongoing correspondences that are being shared with Amesbury Public School families.
- 6. Summer & Fall Planning Superintendent Fulgoni stated there were still many moving parts concerning summer and fall learning. Principal McAndrews addressed the topic in relation to an in person graduation ceremony.

Mayor Gove provided an update to the committee on steps the city was taking due to revenue shortfalls as a result of COVID-19 shutdowns.
