** Other mandatory fees and additional costs are listed below. Tuition amounts include student fees, which help cover the costs of educational supplies, student photos, publications, gym uniforms, and various educational programs.*

Tuition Payment Policy

1. Tuition is due on or before **July 1, 2025**. Tuition is payable in full unless the quarterly or monthly payment plan is selected.
2. The quarterly and monthly payment plans include a deferral fee of 5.0% of the annual tuition due with the July 1 payment. Deferral fees range from \$1,529 - \$1,857, depending on the student's grade.
3. The quarterly plan consists of four payments due July 1, October 1, January 1, and April 1. The monthly plan consists of ten payments due July 1 – April 1.
4. The **TUITION AND FEE OBLIGATION IS FOR THE ENTIRE 2025-2026 SCHOOL YEAR** and will not be waived or refunded unless Kinkaid receives written notice of withdrawal before **April 1, 2025**.
5. An enrollment deposit of \$1,500 is due by **March 1, 2025**, for currently enrolled students or on the contract date for newly enrolled students. **For returning students, the deposit is refundable if notice of withdrawal is provided by April 1, 2025.** The enrollment deposit will be applied to the July 1 tuition statement.
6. Parents with students in grades K-12 may elect to enroll in the **Tuition Refund Insurance Plan**. This program insures tuition (prepaid and due) in the event of extended absence, withdrawal or dismissal before the end of the school year according to the terms of the policy. The premium rate is 0.95% of annual tuition due with the July 1 payment.
7. All families are required to enroll in the School's auto-debit program to pay for monthly incidental charges (dining center, school store, etc.) and quarterly and monthly tuition charges.
8. If payments are not received by the due date, they are considered delinquent:
 - a. A \$40 late fee plus interest of 1.5% per month will be assessed on delinquent amounts.
 - b. Students with delinquent accounts will not be allowed to begin school in August.
 - c. Students with a past due amount of 60 days or more may not attend class or participate in school activities. In addition, enrollment contracts, final grades, and/or transcripts may not be released for students with delinquent accounts.

Mandatory Fees and Additional Cost

- New students are required to pay a new student fee with their July 1 payment to help cover facility costs. The fee is \$1,500 for Prekindergarten and \$2,500 for K-12 grades.
- Trip information and fees, if applicable for 2025-2026, will be communicated at a later date.
- Middle and Upper School textbooks are in addition to the above tuition amounts.
- Lunch is available daily to students in grades 1-12. Students may purchase lunch in the cafeteria by enrolling in the fixed-price lunch plan or on an a la carte basis. Cash is not accepted in the cafeteria, and all purchases are charged to the student's account. Information regarding lunch options is sent to parents during the summer.
