PART I. GENERAL EXPECTATIONS OF THE PARENT INVOLVEMENT POLICY

Dove Virtual Academy agree to implement the following statutory requirements:

- 4. Dove Virtual Academy will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs:
 - Adopting a Park, College Trips with Parents, PTO Meetings, Parent Information Nights (FAFSA, Concurrent, Tech Classes, AP, Scholarship, Extra-Curricular Activities, OK Promise, Science Fair), Virtual Talent Shows, Virtual Language Competitions, End of year Celebrations, Semesterly Parent Picnic, and Bowling with Parents
 - 5. Dove Virtual Academy will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of the school. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background).  - Information on standards and assessments are shared at parent teacher conferences and home visits.

The school will, with the assistance of teachers, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

- Hosting a Back to School Night and Open House.
- 1-1 Parent and Student Orientation
- Offering parents e-mail addresses to all professional staff.
- Offering parents, a home visit during the school year.
- Offering all parents, a secured internet-based grade reporting system.
- Offering information to all parents through the school website.
- Providing all students with a student handbook.

The school will, with the assistance of parents, educate its teachers, pupil services personnel, principals, and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- Administrative team meetings
- Title I staff meetings
- Parent Teacher Organization meetings
- Academic Meetings

The school will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- The school has an EL program, which stands ready to assist any EL families.
- Open House evenings are well publicized.
- Face to face and virtual meetings with parents are encouraged.
- Title I and school newsletters are provided to all families in the school.
