Instructional Aide – Early Childhood

Definition

Under immediate supervision, assist the site supervisor and classroom teacher in a variety of developmentally appropriate activities for children ages twelve months through six years old. Positions in this class are established principally to assist teachers in the care and supervision of children in the District's infant, and preschool special education programs, and school site Transitional Kindergarten (TK) programs. It is distinguished from the Instructional Aide position in that the primary responsibility is to assist in the general care, supervision, and instruction for the whole child whereas Instructional Aides are primarily responsible to assist in formal instruction.

Essential Duties and Responsibilities

- Supervises the activities of individuals or groups of students;.
- Assists in arranging rooms and other materials to accommodate the daily schedule;
- Supervises and implements teacher-directed instructional and developmental activities;.
- Maintains a neat, orderly, safe, and attractive work environment:
- Prepares instructional materials as directed;.
- Assists children with developmental self-help skills;.
- Attend<u>s</u> to the physical needs of the children such as diapering, feeding, toileting, and resting;
- Guides children in recreational and learning games and activities;.
- Perform<u>s</u> and assist<u>s</u> the team with District-approved Emergency Behavioral Interventions when needed;
- Maintains informational records which may include health or behavior charting;.
- Supervise<u>s</u> or assist<u>s</u> students to and from the school bus or other transportation, and in moving to and from activities;
- Assist<u>s</u> teachers with <u>the</u> implementation of student's IFSP/IEP through instruction in a wide variety of activities, such as story time, playing games, art activities, singing, dance, outdoor recreation, and instruction;.
- Attend<u>s</u> a variety of meetings, workshops, and training courses as required.

Required Qualifications

- Current CPR and First Aid certification prior to starting the assignment and **<u>always</u>** maintain current at all times;.
- The equivalent of graduation from high school and either completion of at least two years of study (48-semester units or 60 quarter units) at an institution of higher education or attainment of an Associate degree or higher.
- A valid California Driver's License or state issued identification.

Preferred Qualifications

- Completion of coursework at an accredited institution of higher education in early childhood education or child development.
- Bilingual in any language including American Sign Language is highly desirable.

<u>Ability to</u>

- Learn school policies, methods, and practices generally used with students in a classroom setting;.
- Nurture a culturally sensitive environment where children can develop to their full potential;.
- Project a warm and friendly manner and disposition.
- Use good judgment in a variety of circumstances and situations;.
- Communicate effectively;.
- Understand and follow oral and written directions;.
- Establish and maintain cooperative and effective working relationships with children and adults;.
- Communicate fluently in English and demonstrate proficiency in reading, writing, and speaking of another language when identified as a requirement;.
- Provide specialized health care when identified as a requirement.
