Providing All Children Equal Access to Education, Regardless of Immigration Status January 30, 2025

WHEREAS, according to the District mission statement, the Pleasanton Unified School District Board of Education is committed to ensuring that every student develops the enduring knowledge, skills, and character to make a better world;

WHEREAS, Pleasanton Unified School District school sites include any and all locations hosting district funded or district co-sponsored classes, educational programs, or enrichment activities;

WHEREAS, public schools and school districts in California are subject to all federal and state laws, and constitutional provisions prohibiting discrimination on the basis of race, color, gender, sexual orientation, gender identity, transgender status, religion, national origin, ancestry, age, immigration status, marital status, pregnancy status, veteran status, or disability;

WHEREAS, as outlined in our Pleasanton Unified School District nondiscrimination policy, we commit to providing a safe environment where all are treated equally regardless of race, color, creed, religion, ancestry, age, national origin, sex, sexual orientation, marital status, gender identity, disability, or need for special education services. This means that all children are embraced as full members of our school community, and that all students have a right to an education, regardless of any difference;

WHEREAS, education has a critical role in furthering tolerance and strengthening our society;

WHEREAS, as a school district, we are committed to remaining nonpartisan on politics while fulfilling our commitment to maintaining schools and classrooms that are safe and inclusive places for all students and families;

WHEREAS, the District believes that collaboration between schools and families is essential for student success and that building trust with immigrant families is paramount;

NOW, **THEREFORE**, **BE IT RESOLVED**, that the Pleasanton Unified School Board of Education directs the Superintendent to support a school district that is safe for immigrant students.

BE IT FURTHER RESOLVED, that the District will NOT:

- Allow immigration enforcement agents access to District campuses or facilities without a valid warrant;
- Share student or family information with immigration authorities unless required by law;
- Discriminate against any student or family based on immigration status; and

BE IT FURTHER RESOLVED, that the District will:

 Provide accurate and accessible information to immigrant families about their rights and resources;

- Work to build trust and collaboration with immigrant families;
- Promote a welcoming and inclusive school climate for all students; and

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately.
