## Subcommittee Workshop – Complete Triennial Assessment (2022 done/revision working on)

- In 2016 new requirements from state about wellness policy and triennial assessment was added. Need to submit the template for Assessment. Never made it to the board until 2023. This year's review for Assessment (WSCC Website). No one was entirely sure what they were asking before. It was submitted incomplete. CDE reviewed it and let us know what was missing. We are working on completing this. We are understanding better what they want. Need to get with who needs to complete the 2022 assessment that was never complete. FINDING: State goals, state progress of goals. Wellset 3.0 comparing our policy to model. We did achieve that. Two or three other sections need to do before June 15<sup>th</sup>. ? / Extent/ make public. Not all components were done. Let them know our plan by June 15<sup>th</sup>.
- 2022 – Dominic, Sneh, Terri and Gaylon helped us do the assessment
- Put plan in place August or September 2024.
- Subcommittee meetings in 2023 to come up w/plan to get all sites in compliance. Hardest thing will be to ensure all sites are in compliance or at least working their way towards compliance.
- They (CDE) want to see progress.
- By Spring hopefully we'll have some schools in compliance and many on their way. Progress.
- SNEH – important for our group... we will need help from committee to get to schools in compliance. We need to share wellness policy with site administrators. Paulette Erfert agrees. Too many cupcakes. Do they know about the wellness policy? The wording for the wellness policy came from Legal Services. It will be difficult to send this info to some schools because administrators will be different by next year. Wait to send those out till beginning of next year.
