CALL TO ACTION

The [Long Beach Unified School District](#) stands in solidarity with our immigrant students and families. We are committed to providing a safe, supportive and inclusive learning environment for all students, regardless of immigration status.

LBUSD BOARD OF EDUCATION

[The Governing Board](#) is committed to the success of all students and believes that every school site should be a safe and welcoming place for all students and their families irrespective of their citizenship or immigration status. Please refer to our [Response to Immigration Enforcement Policy](#).

DISTRICT RESPONSE

If U.S. Immigration and Customs Enforcement (I.C.E.) Appears at an LBUSD School:

- **LBUSD employees** are directed to **not share any information** about students, families or staff unless instructed by the [Office of General Counsel](#).
- **Staff, teachers, students and parents** should immediately refer I.C.E. agents to a **school administrator** (or designated responder).

PROACTIVE MEASURES FOR FAMILIES

Take these steps now to ensure your family is prepared:

1. **Update School Emergency Contacts:** Ensure multiple trusted adults are listed to pick up your child.
2. **Complete a Family Preparedness Plan:** Keep contact sheets and key documents accessible.
3. Save Important Numbers:
 - Your child's school office and afterschool provider.
 - Key support organizations listed below.
4. Know Your Rights: All people, regardless of immigration status, have rights under the U.S. Constitution.
 - Visit [Immigration Legal Resource Center](#) for resources.
 - Red Cards are available at all school sites in requested languages.
 - Know Your Rights workshops will be offered in partnership with trusted organizations.

KNOW YOUR RIGHTS!

I do not wish to speak with you, answer your questions, or sign or hand you any documents based on my 5th Amendment rights under the United States Constitution.
I do not give you permission to enter my home based on my 4th Amendment rights under the United States Constitution unless you have a warrant to enter, signed by a judge or magistrate with my name on it that you slide under the door.
I do not give you permission to search any of my belongings based on my 4th Amendment rights.
I choose to exercise my constitutional rights.
These cards are available to citizens and noncitizens alike.

RED CARDS

- **Know Your Rights:** All people, regardless of immigration status, have rights under the U.S. Constitution. The Immigrant Legal Resource Center's (ILRC) Red Cards help people assert their rights and defend themselves in many situations, such as when I.C.E. agents go to a home.
- When interrogated by federal immigration officials, **you have the right to stay silent.** Hand the **Red Card** to the officer and remember that you do not have to answer any questions.
- **RED CARDS** are now available at all Long Beach Unified Schools in up to 16 different languages. Please contact your school office for specific language requests on red cards.

RED CARDS EXAMPLES

SPANISH

Usted tiene derechos constitucionales:

- NO ABRA LA PUERTA si un agente de inmigración está tocando la puerta.
- NO CONTESTE NINGUNA PREGUNTA de un agente de inmigración si el trata de hablar con usted. Usted tiene el derecho de mantenerse callado.
- NO FIRME NADA sin antes hablar con un abogado. Usted tiene el derecho de hablar con un abogado.
- Si usted está afuera de su casa, pregunte al agente si es libre para irse y si dice que sí, váyase con tranquilidad.
- ENTREGUE ESTA TARJETA AL AGENTE. Si usted está dentro de su casa, muestre la tarjeta por la ventana o pásela debajo de la puerta

អ្នកមានសិទ្ធិតាមរដ្ឋធម៌៖

- កុំបើកទ្វារប្រសិនបើអ្នកបម្រើការងារជាតិបានទទួលការចូលមកនៃអ្នកយកចំលែកតាមច្បាប់។
- កុំឆ្លើយសំណួរអ្វីៗពីអ្នកយកចំលែកតាមច្បាប់ប្រសិនបើពួកគេព្យាយាមនិយាយជាមួយអ្នក។ អ្នកមានសិទ្ធិនៅក្នុងការស្ងាត់។
- កុំចុះហត្ថលេខាត្រឹមត្រូវជាមួយកិច្ចសន្យាអ្វីៗទាំងអស់មុនពេលដែលអ្នកនិយាយជាមួយមេធាវី។ អ្នកមានសិទ្ធិក្នុងការជជែកជាមួយមេធាវី។

ENGLISH

You have constitutional rights:

- DO NOT OPEN THE DOOR if an immigration agent is knocking on the door.
- DO NOT ANSWER ANY QUESTIONS from an immigration agent if they try to talk to you. You have the right to remain silent.
- DO NOT SIGN ANYTHING without first speaking to a lawyer. You have the right to speak with a lawyer.
- If you are outside of your home, ask the agent if you are free to leave and if they say yes, leave calmly.
- GIVE THIS CARD TO THE AGENT. If you are inside of your home, show the card through the window or slide it under the door.
