#### SPOTLIGHT SEGMENT

Directors received an overview of the 21st Century Community Learning Centers (CCLC) after-school and summer programs. STEAMS (Science, Technology, Engineering, Arts, Mathematics) and Pathfinders serve students ranging in grades K-8 across seven local districts, offering hands-on enrichment in STEM, literacy, social-emotional learning, physical fitness, and homework assistance. Funded by the Pennsylvania Department of Education, CCLC is administered by the CSIU. Directors also received information about the statewide support provided by the Center for Schools and Communities.
