## REQUIRED QUALIFICATIONS



- Current FCS educator with at least three (3) years of special education teaching performance with at least 1 year being in FCS (Note: being a GE teacher in a co-taught setting does not count towards these 3 years of experience)
- Valid Clear & Renewable Georgia Teacher Certification in one or more areas of Special Education; Leadership certification strongly preferred
- Master's Degree in relevant field
- Knowledge of special education laws and regulations
- Excellent interpersonal, organizational, and communication skills
- Provide current principal, current IST, and a special education colleague recommendation with their signature

## PREFERRED QUALIFICATIONS



- Current FCS educator with at least five years of special education performance
- Endorsements such as, but not limited to: Teacher Support Specialist Endorsement,
  Reading, Math, or ESOL Endorsement
- Leadership experience such as, but not limited to: Curriculum Support Teacher, Instructional Coach, Data Support Specialist, Administrative Assistant, Department/Grade Level Chair, Professional Learning Facilitator, Professional Learning Community Lead, Induction Advisor, etc.


