



**WE HAVE FOCUSED MOST OF OUR PROFESSIONAL LEARNING THIS YEAR ON PROFICIENCY SCALES. OUR TEACHERS NOW HAVE A DEEPER UNDERSTANDING OF THIS ELEMENT, THUS CREATING A KNOWLEDGE BASE LEADING TO BETTER REFLECTION AND REALIZATION OF ALL THAT IS REQUIRED TO EMBED SCALES IN THE CLASSROOM....WHICH IS NEEDED FOR LEVEL 3 ATTAINMENT. DUE TO THIS NEW LEVEL OF UNDERSTANDING, OUR LEVEL 3 ATTAINMENT PERCENTAGE HAS DROPPED.

**12% OF THE ELEMENTARY EDUCATORS ARE AT A LEVEL 3.



**47% OF THE ELEMENTARY EDUCATORS ARE AT A LEVEL 3.


