Discussion items:

Class I : Residential/Agricultural Tax Value 2024 (\$226,912,010) for collection in 2025 currently taxed at 20 mil floor per HB 920

Class II : Commercial Property 2024 Tax Value (\$9,906,200) currently collecting at 31.07 mills

Public Utility Tax Revenue: Current Tax Value: (\$282,381,880) currently collecting at 47 mills.

Public Utilities refer to the tax assessed on the infrastructure and assets owned by utility companies, which include underground pipelines, gas lines, electric transmission poles, and various equipment such as compressors and wellheads. These assets are often located on property owned by other entities, enabling the utility companies to provide essential services to the public. A few examples of the companies that are assessed tax through the public utilities are Ohio Edison, Firelands Electric, Rover

Pipeline, Columbia Gas, TransCanada, and Northeast Ohio Natural Gas Corp.
