ii. Academy Building Restoration Project Update

Mr. Susi shared that the elevator parts, as well as pieces of tempered glass and shutters, should arrive next week. The project is going well, and everything seems to be working as it should.

iii. Tennis Court Project Update

Mr. Susi stated the engineers have presented to the Planning and Zoning Commission, and after follow-up issues have been addressed, the project should move forward. We still must decide on the surface material to create the RFP and set the financing. Target completion is hoped to be in the fall. iv. 2022-2023 Audit

Winter Updates from the Associate Head of School

School Updates

- The Woodstock Academy received an award from the Putnam Rotary Interact Club for giving the most volunteer hours of any school for the holiday Salvation Army Bell Ringing.
- The 2023 4-year Cohort Graduation Rate is 98.1%. Of the 6 students that did not graduate in 4 years, 1 student graduated a few months late, and 3 students, as special education students, will remain in school until age 22.
- Lots of visits to WA this month and upcoming! Apple Distinguished School selection committee visited on 2/1. Connecticut Association of Independent Schools (CAIS) sent a teacher delegation to WA as part of their POV program. Principals from Kazakhstan will be visiting in April. And, students from Japan will also be visiting in April.

- WAMUN won the Best Small Delegation award at Brown University's MUN Conference. Four Students won individual awards: Filip Nemcek (T), Best Delegate; Owen Rigney (W), Best Delegate; Maggie McHugh (W), Outstanding Delegate; and Tanner Graham (W), Honorable Mention.
- Two teams won awards at the REC Aerial Drone Competition Teamwork Competition, Think Award, and Flight Operations Award. Team members are Abigail Converse (W), Heath White (P), Maria Castaneda Banderas (W), Anthony Beaudreault (W), Diya Patel (W), David Sumner (B), and Evan Anderson (B).
- The WA Debate team came in 2nd place at the Plainfield Regional Debate Competition. Each participant also won individual awards: Julia Coyle (P) and Cade Jones (U) received Most Valuable Debater, Aiden Finch (W) received the 3rd Highest Individual Scorer, and Charlie Caggiano (W) received the 4th Highest Individual Scorer and the Teamwork Award.
- Several members of the Prep Soccer Program have been invited to try out, and some to join the Under 20 National Teams of their respective countries. Enoch Joseph and Xahvi DeRoza will play for Bermuda. Ahir Dixon will play for Jamaica. Ajani Banton will play for Barbados. Alvaro Medrano Jr. will play for Guatemala.
- Carlos Rodriguez (T) was selected to attend the Winter Youth Olympic Games in his country, South Korea.
- 17 students were accepted into the NEMFA Festival. Emma Costa (P), Olivia Dahl (W), Lilah Jafar-DeCesare (W), Madison LaVallee (B), Kayleigh Murray (B), and Giulia Musumeci (W) will participate in the band. Kate Ritzau (T) will play in the orchestra. Emily Cournoyer (W), Nathan Couture, (W), Ben Cross (W), Chandler Folkerts (W), Judah Gagnon (P), Lilah Lily Mercier (W), Xander Miller (W), Apollo Ruoppo (B), Michael Susi (W), and Sadie Wood (W) will sing in the chorus.
- 4 students were named Scholastic Art Competition winners: Jillian Wiggin (B) in ceramics and glass, Finley Couture (B) in mixed media, Audrey MacPherson (P) in drawing and illustration, and Chandler Folkerts (W) in digital art for 4 different pieces.
- 3 students won individual awards at Columbia's MUN Conference in January: Filip Nemcek (T) and Evelyn Young (T) received Honorable Mention awards. Owen Rigney (W) received an Outstanding Delegate award.
- 2 students won individual awards at St. John's Prep School Model UN Conference: Filip Nemcek (T) won Best Orator and Evan Rhault (W) won Best Delegate.
- Last weekend, the Aerial Drone Team qualified for the New England Competition with a Judges' Award. Team members were Tristan Serating (P), David Sumner (B), Riley Mathews (P), and Ivar McDonald (W).
