OATH OF OFFICE TO BOARD MEMBERS

Motion 1m-1-25 ELECTION OF BOARD PRESIDENT

Moved by Derek Miller, that William Poe II be nominated as WBESC President for calendar year 2025.

- K. Motion to approve the Treasurer and Assistant Treasurer as designees to attend required Public Records Training for Western Buckeye ESC Governing Board Members.
- L. Motion to designate the Treasurer to sign all Governing Board of Education checks, or the Assistant Treasurer, if so directed by the Treasurer.
- M. Motion to approve the Treasurer to invest all inactive funds through 2025 and to advance monies from fund to fund as needed.
- N. Motion to authorize the Treasurer to pay all bills within the limits of appropriations as bills and services are received.
- O. Motion to appoint the Superintendent as Purchasing Agent for 2025 with a maximum of \$50,000 without Board approval.
- P. Motion to appoint the Superintendent as contact person in Federal projects and programs.
- Q. Motion to approve the Superintendent to employ temporary personnel, authorize attendance at professional meetings and act on behalf of WBESC within the limits set by the Governing Board.
- R. Dispense of the reading of the “minutes” of the previous meeting.
- S. Authorize the Superintendent and Treasurer to enter into and/or accept participation in federal, state, or local grants for agreements deemed advantageous to the ESC and authorize the Treasurer to appropriate funds for grants awarded.
- T. Authorize the Superintendent and Treasurer to accept all donations to the ESC on behalf of the Governing Board.
- U. Authorize the Superintendent, during periods when this Board is not in session, to make offers of employment directly to candidates for either teaching or non-teaching position on behalf of this Board, and to acknowledge acceptance of such offers on behalf of this Board, subject to a

subsequent vote of ratification by this Board, the employment shall be deemed effective as of the date and time of the employee's acceptance of the Superintendent's offer.

- V. Authorize the Superintendent, on behalf of this Board to accept resignations which have been submitted by employees during times when this Board is not in session, subject to ratification by this Board; provided however, that upon ratification by this Board, such resignations shall be deemed effective as of the date and time of the Superintendent's acceptance.
- W. Approve a motion authorizing the Treasurer and Superintendent to make certain proper public expenditures on behalf of the Governing Board to promote staff morale including professional development, beginning of year and end of school year staff breakfasts, lunches, dinners, refreshments, funeral memorials, and/or gifts.
- X. Recommend the Board appoint the Board President as Treasurer Pro Tempore in 2025, in the absence of the Treasurer.
- Y. Authorize the Superintendent to approve intermittent dock days for staff in cases where the best interest of the ESC might be served. [These intermittent dock days approved by the Superintendent do not need to be presented to the Governing Board for approval].
- Z. Approve the current year Board President to serve as the President Pro-Tem for the Organizational meeting.
