Shall the School Board of Independent School District No. 2903 (Ortonville Public Schools), Minnesota be authorized to issue general obligation school building bonds in an amount not to exceed \$36,080,000, for the purpose of providing funds for the acquisition and betterment of school sites and facilities, including, but not limited to areas including school safety, classroom and program enhancements, aging infrastructure, and community spaces?


The ballot question, having not received the approval of a majority of the votes cast, is hereby declared to have not carried.

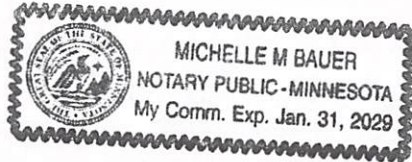
