**CALALLEN INDEPENDENT SCHOOL DISTRICT**

**AN ORDINANCE OF THE BOARD OF TRUSTEES TO SET THE 2024 TAX RATE**

On this date, we, the Board of Trustees of the Calallen Independent School District, hereby levy or set the tax rate on \$100 of valuation for the District for the tax year 2024 at a total tax rate of \$ 1.0403, to be assessed and collected by the duly specified assessor and collector as follows:

**\$ 0.7695** for the purpose of maintenance and operations, and

**\$ 0.2708** for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.

**THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**

**THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.78% PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$28.06.**

Adopted by the following record supermajority vote of the members of the Board of Trustees (5 of 7 members regardless of meeting attendance) of the Calallen Independent School District present and voting at an open meeting of the Board on the 26th day of August 2024, at which a quorum was present.
