### Community Advisory Committee Meeting Minutes January 22, 2025

#### A. Call to Order

Ryan Digman, CAC Chair called the meeting to order at: 6:04 p.m.

#### B. Member Roll Call

#### C. Visitor Comments

Ben Avey shared his appreciation and gratitude for the work of the CAC and introduced Nick Bloise, who will serve as the alternate board member liaison. Mr. Avey shared updates and information from the latest school board meeting in regards to our multi-language learners and the amount of growth in our district. Mr. Avey shared there has not been a decline in enrollment in San Juan Unified.

#### D. Visitor Comments

Caroline Digman, parent and teacher in the district, spoke about the Sacramento Reading Coalition and the importance of structured literacy and screening for reading difficulties. Caroline shared there will be public comment at the next board meeting on January 28, about structured literacy.

Monique, parent, shared about parent's night out on February 28 at El Palmar restaurant.

Kirsten, parent of a student who attends Barrett Middle School, shared her concerns regarding the lack of information on continuum of services and co-taught classes. Kirsten is requesting transparency in accessibility of this information and urging the district to provide a list of middle and high schools that offer co-teaching classes.

Marsha, parent, expressed concern about options for students with disabilities and the challenges students face. Marsha shared there should be more paths toward trade schools and electives based in trades.

Angela, parent of a student, shared CTE should be offered for elementary students and done in age appropriate ways.

### E. TeachTown Presentation

Alexandra Card, Special Education Curriculum Specialist, gave a presentation about TeachTown and implementation of this curriculum in San Juan Unified for elementary, middle and high school students. The TeachTown presentation is attached at the end of these notes

### Member Discussion:

Kasey Crooks asked how transparent the conversation is for the graduation pathway. Rebecca Foster responded that this should be part of the IEP discussion between the team and the parent of the student.

Sean Owens shared this curriculum is used dependent on the age groups, for example, Sean teaches an elementary ILS class.

Christie Waldron shared about TeachTown use at Ralph Richardson.

Ryan Digman shared there needs to be more engagement from the community and parents when choosing and adapting curriculum.

Nicole Harrigan asked about student count in the moderate/severe program and asked what the plan will be to make the use of curriculum mandatory.

Heather Taylor asked about the pace of the curriculum and how it is applied for alternative pathway. Heather also asked if training was voluntary. Heather asked

Lisa Sotelo asked if program specialists have been taught this curriculum and if it's something that needs to be asked for by the parent.

Kasey Crooks asked how many languages this is offered in. Currently only two languages.

Kimber Rice asked for clarification about the board 's adopted curriculum applying to all teachers and if there is currently any board adopted curriculum for moderate/severe students. Amy Slavensky shared that there are state requirements to adopt the core curriculum. Rebecca Foster shared that there currently is no board adopted curriculum.

Ryan Digman shared that the roll out for this curriculum was not accessible for parents and community members. Ryan shared there should be more opportunity to utilize this program at more sites and students face challenges when wanting to access this curriculum.

Mackenzie Guye shared about screen-based learning and the student's curriculum may change based on the student's placement and need.

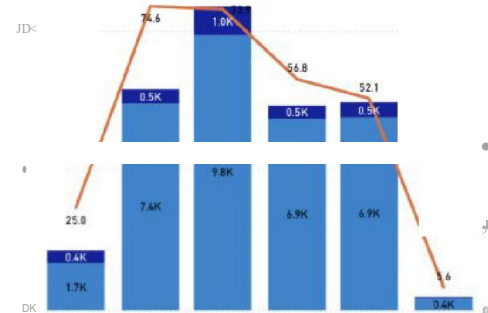

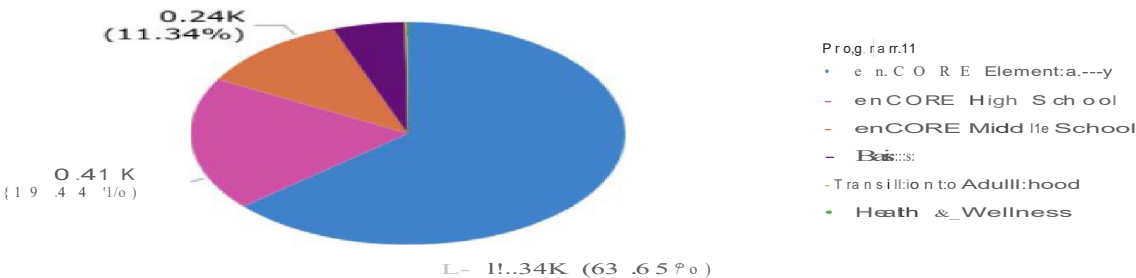

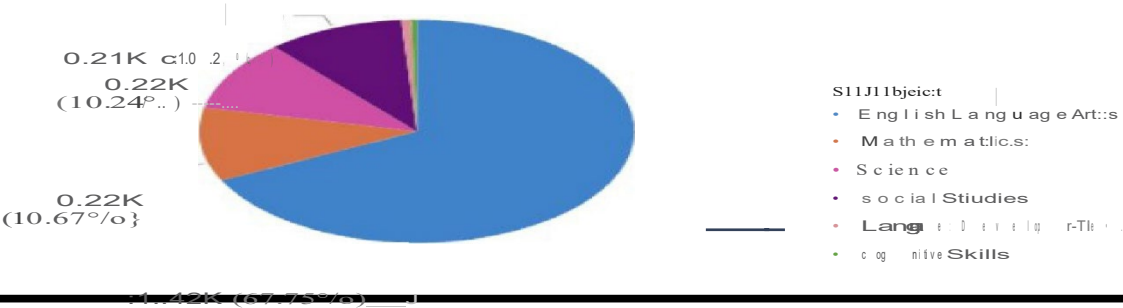
