EGG HARBOR CITY BOARD OF EDUCATION REGULAR MEETING

December 14, 2011

The regular meeting of the Egg Harbor City Board of Education was held on the above date at 7:00 p.m. at the Egg Harbor City Community School, 730 Havana Avenue, Egg Harbor City, New Jersey, with President Stephen Bouchard opening the meeting, and board members, Michael Beaulieu, Janine Brown, Rick Dovey, Scott Senn and Jeanne Williams present. The District has obtained copies of the purchase orders from SDA and will review those purchase orders in order to provide actual historical costs and update the inventory accordingly.

2. Pay to play information was not obtained for all vendors prior to contracts being issued or purchase made.

Corrective Action: The District has reviewed the vendor history report and has received pay to play documentation from all vendors who are required to submit pay to play documentation.
