HAIS TXOG QHOV UAS, Fresno Unified School District muaj kev cog lus ntev hais txog kev sib luag, txoj cai ncaj ncees rau tib neeg, thiab kev tswj saib xyuas kom tsev kawm ntawv yog chaw uas muaj kev nyab xeeb tsis muaj kev ntxub ntxaug cais tawm lossis kev yuam kom ua raws li cai uas yuav cuam tshuam rau ib puag ncig kev kawm;

Doe (1982) lub Tsev Hais Plawb Siab Tshawj Plaws ntawm Tebchaws Ameskas tau txiav txim tias txhuas tus menyuam hlab teb chaws yeej yog tib neeg “raws li qhov kev txhais tau ib txwm muaj ntawm lo lus” thiab yog li ntawd muaj kev tiv thaiv los ntawm kev ntxub ntxaug cais tawm raws li txoj cai loj ntawm 14th Amendment, thiab hais tias taghro cov menyuam, txawm yuav hla tebchaws tuaj li cas, muaj cai tau txais kev kawm ntawv dawb ntawm pejxeem cov tsev kawm ntawv;
