The Hazelwood School District Child Nutrition Services Department is soliciting bids for the 2019 - 2020 school year for the following the areas: grocery, bread, milk, disposables, beverages and cleaning products for 32sites.

The first day of school is August 13, 2019 and the last possible day will be June 8, 2020. We are requesting two deliveries per week to all schools for everything except bread and milk which are to be delivered daily. Deliveries are to be made between the hours of 6 a.m. and 2:00 p.m. except at the 3 high schools which require deliveries to be made before 9:00 a.m. two times per week.

Hazelwood School District is interested in having one prime vendor for the entire bid. However, because of the fresh nature of bread, milk, and produce this may be awarded to a separate vendor or in combinations, whichever is to the advantage of the Hazelwood School District. Hazelwood School district reserves the right to award the categories to vendor (s) which is deemed most beneficial to the Hazelwood School District.

The successful bread vendor is to supply racks, one per each elementary school and several for each secondary school to be determined by kitchen manager based on average daily participation. Bread products are to be delivered on clean, sanitary trays. All products are to be fresh daily. If at any time we are not satisfied with the quality of your service, our agreement will be terminated with two weeks' notice.

Itemized monthly statements in duplicate shall be mailed to the Finance Office by the 5th of the month following deliveries. This address is to be

The Hazelwood School District reserves the right to reject any or all bids submitted. The Hazelwood School District has tax exempt status.

The successful Vendor must meet the following terms and conditions.

- A. <u>PROFESSIONALISM</u>: The District reserves the right to remove any individual employed by the Vendor from the District's property who may not be conducting him/herself in a professional manner or who may not be dressed properly, if it is in the best interest of the District.
- B. <u>HACCP REQUIREMENTS</u>: The District expects a Hazard Analysis Critical Control Point (HACCP) plan to be in place by potential vendors and their manufacturers. Prior to awarding the bid, the District may require documentation.
- C. <u>STANDARDS OF IDENTITY</u>: All products must conform to U.S. minimum standards of identity as authorized by the Food, Drug and Cosmetic Act and the supporting regulations in 21 CFR. Failure to comply places the Proposer in violation of the contract with the District as well as Federal law.
- D. <u>DELIVERY LOCATION</u>: After award, all deliveries shall be made and all services provided to the location specified by the Child Nutrition Department.
- E. <u>STANDARD CONDITIONS OF BID</u>: Delivery charge to be INCLUDED in price quotations.

 Substitutions to be approved by Child Nutrition Services Office prior to delivery. Substitution without prior approval is cause for disqualification of entire Bid. Bid quantities will be met as nearly as possible based on budgetary guidelines and student participation. All factors including service, accuracy, price and other amenities will be considered when evaluating the bids. Hazelwood Child Nutrition Services will perform a cost or price analysis wherein independent estimates are created prior to issuing the request for proposal.

Hazelwood Child Nutrition Services reserves the right to reject any or all bids based solely on Hazelwood Child Nutrition Services evaluation and to waive any technicalities. This does not obligate Hazelwood Child Nutrition Services to pay any costs incurred by vendors related to submission of proposals in response to this request for bids. Hazelwood Child Nutrition Services may wish to visit Supplier's facilities, warehouse(s), or other facilities and may use the visitation as a basis for accepting or rejecting proposals. Supplier(s) shall, upon request and at no charge, accompany Hazelwood Child Nutrition Services personnel.

Hazelwood Child Nutrition Services shall have the right to reject any or all products furnished, which in its sole opinion, are not in strict conformity with the requirements of the bid specifications.

- F. <u>PRICES</u>: All bids shall be deemed final, and no bid shall be subject to correction or amendment for error or miscalculation. All bid prices shall be quoted as 'delivered' prices to each Hazelwood Child Nutrition Services location in St. Louis County, Missouri, unless otherwise specified.
- G. <u>NUTRITION</u>: The successful vendor must provide Nutrition information, ingredient information, Child Nutrition Statement, and Certification of Compliance with meal requirements for the National School Lunch and Breakfast Program under the Healthy, Hunger -Free Kids Act of 2010.

H. CONDITION AND QUALITY OF GOODS

Any products dated or coded for freshness must be delivered prior to the end of its freshness period and with a minimum of 10 days' duration prior to expiration or pull date of product. Any outdated products received will be rejected, and Vendor will be required to credit the value of these products to the District. The successful Vendor must supply any freshness code information to the District authorized representative prior to the first product delivery of the school year and/or when there are any changes in the coding

I. ORDERING AND DELIVERY PROCESS

- a) Orders will be placed via distributor's website, e-mail, or phone by Hazelwood School District Child Nutrition Services.
- b) Unless otherwise specified the vendor must agree to deliver to all specified sites.
- c) Drivers will be required to deliver product to designated area of each site.
- d) All products must be delivered in a manner which will maintain proper temperatures as dictated by the local health authority.
- e) Delivery vehicles and equipment must meet all sanitation standards in accordance with local, state and federal food safety guidelines.
- f) Hazelwood School District Child Nutrition Department reserves the right to refuse at time of delivery all products deemed unacceptable by district Representative(s) or any product not delivered within specified time(s).
- g) The quantities specified in the bid specifications for each product are estimates and may increase or decrease.

Any deviation from established standards shall be considered sufficient cause for cancellation of the contract. All dairy products shall be produced and handled in accordance with the best sanitary practices.

Supplier Diversity

The Hazelwood School District has established a Supplier Diversity Program to provide opportunities for the meaningful participation of Minority Business Enterprises (MBEs) and Women Business Enterprises (WBEs) in purchases made by the District. The District has established a MBE goal of fifteen percent (15%) and a WBE goal of five percent (5%) utilization for all manufacturers, suppliers of goods, and brokers.

A manufacturer, supplier of goods, or broker who has achieved the participation goals for MBE/WBEs, as defined herein, will be in compliance with the requirements of this specification. A manufacturer, supplier of goods, or broker who cannot achieve the goals for MBE/WBE participation must be able to demonstrate that the required positive efforts were initiated prior to submittal of the proposal. If the business partner cannot demonstrate the required positive efforts, the proposal will be rejected as non-responsive.

The District will accept, as prospective MBE/WBE participants for these projects, only those MBE/WBE firms which have been certified by one or more of the following agencies on or before the date of the bid opening:

- 1. City of St. Louis (St. Louis Development Corporation/Airport Authority)
- 2. St. Louis Minority Supplier Development Council (SLMSDC)
- 3. Missouri Regional Certification Committee (MRCC)
- 4. State Certifications, e.g., the State of Missouri and other states
- 5. National Minority Supplier Development Council (NMSDC)
- 6. Women Business Enterprise National Council (WBENC) and its affiliates

In the case of a manufacturer, the District will also accept MBE/WBE certification by any state division of purchasing or the National Minority Supplier Development Council and its affiliates.

HSD reserves the right to reject any certification if it is discovered that the same entity was denied certification by any of the other agencies listed above. If HSD does not accept a MBE or WBE's certification, HSD will notify the MBE or WBE in writing.

The Hazelwood School District reserves the right to reject any or all bids submitted. All bids must comply with the policies of the Hazelwood School District. We have tax exempt status.
