<ul style="list-style-type: none"> <li>• Meeting Minutes Approval</li> </ul>	<ul style="list-style-type: none"> <li>• Ms. Lafrentz motioned to approve October 10, 2024 meeting minutes. Ms. Almada seconded the motion, however, the motion was not debated or voted upon.</li> </ul>
<ul style="list-style-type: none"> <li>• Public Comment(s)</li> </ul>	<ul style="list-style-type: none"> <li>• Principal Lenzi welcomed our parent attendees, but also shared that ELAC meetings are still in need of more parent community participants.</li> <li>• Angelica asked how MLLs get ready for the ELPAC Test. Ms. Lafrentz shared that teachers have been provided with ELPAC Practice Tests to review with their MLLs in class.</li> <li>• Angelica asked if access to english language services and support would be limited once an MLL is reclassified as being english proficient? Could an MLL be reclassified too soon or before they are truly ready? Ms. Almada and Principal Lenzi addressed Angelica's concern by clarifying the four criteria needing to be met, and how the decision to reclassify an MLL must be made with the input gathered from school staff and parents.</li> </ul>

	<p>reclassified as Fluent English Proficient (RFEP) when they demonstrate English proficiency.</p> <ul style="list-style-type: none"> <li>• That reclassification allows for students to access their full grade-level curriculum without English Language Development (ELD) support, allows for students to no longer be required to take the ELPAC annually, allows for students to be monitored for 4 years to ensure continued academic success, and allows for students to participate more fully in advanced coursework, college preparation, and career pathways.</li> <li>• That in order to be reclassified, MLLs must meet <b>four</b> criteria, <b>Language Assessment, Teacher Evaluation, Parent/Guardian Consultation, and Basic Skills Assessment.</b></li> <li>• Special considerations made available for MLLs with disabilities.</li> <li>• How parents of MLLs can best support their child and the reclassification process.</li> </ul>
