



## Stonington Public Schools

**ELIGIBILITY:** A child must be five years old on or before September 1, 2025. State law requires students to register for school by age 6. ### **STEP 3: Required Documents for Registration**

#### **1. Proof of Residency - minimum of 3 documents are required**

- Signed lease/rental agreement or mortgage statement/deed **MANDATORY**
- Current utility bill (electric, gas, phone, cable, sewer or water) dated within 30 days
- Driver's license/State ID

#### **3. Legal Guardianship/Custody Papers (if applicable)**

• Proof of legal guardianship is also required if you are not the birth parent or if you are divorced, such as: adoption papers, court order clarifying guardianship, guardianship papers from probate court, DCF form 603 (must be signed by DCF or legal designee).

#### **4. State Mandated Physical & Immunizations**

• State mandate physicals must be completed between January 1st and December 31st of the calendar year the child starts school. Physicals and immunizations can be emailed to the nurse. For all other health related questions, please contact the school nurse.
