Tuesday, February 25, 2025	Present preliminary 2025-26 Budget forecast, Rockefeller Report, Foundation Aid, and budget assumptions to the Board of Education, Release of Budget petitions for BOE Candidates.
Friday, February 28, 2025	Submit the Tax Levy to Office of State Comptroller's Website.
Tuesday, March 11, 2025	Present Preliminary Revenue, Tax Levy Limit, and Gov's Budget to Board of Education.
Tuesday, March 25, 2025	Budget Preliminary Expenditure Budget Presentation to Board of Education. Legal Notice of date, time, and place of School Budget Hearing and Annual Budget Vote Approval.
Friday, April 4, 2025	Legal Notice #1
Tuesday, April 15, 2025	2025-2026 Preliminary Budget Presentation, BOE adoption of Property Tax Report Card and Final 25-26 School Year Budget.
Wednesday, April 16, 2025	File Property Tax Report Card.
Friday, April 18, 2025	Legal Notice #2
Monday, April 21, 2025	Last Day to file petition with the District Clerk to run for the Board of Education. (30 days prior to election) District Clerk draws lots for place on ballot - 4:00 p.m. at the District Office.
April 22-May 13, 2025	Mail absentee ballots to those who request one.

Friday, May 16, 2025	Legal Notice #4
Tuesday, May 20, 2025	Statewide annual meeting/board election/budget vote day.
Tuesday, June 17, 2025	Statewide budget revote day.
