REPORT OF COMMITTEES OF THE BOARD OF EDUCATION

- Mrs. Young, Buildings and Operations Franklin and Carson HVAC projects are about 70% complete. The High School parking lot expansion project is ongoing and may be completed by the end of the year. Two bids were received for the Magnet school project. The lowest bid is within budget, which is good news. The pre-school expansion grant was approved at the highest rate available in the State, for this type of project. The remaining cost for the project will be encumbered within the district budget. This project will be completed after the Magnet school project is completed. We are updating the camera systems on our buses.
- Ms. Johnson, Education Committee We are introducing translate ear buds at the High School to assist students and teachers with translation for initial students coming into the district. We will be having a new elementary math pilot program for grades K-5. In the spring, parents will be invited to get a better understanding of the concept and be able to assist the students more and gain a better understanding of how the program is working. There will be testing 3 times a year in order to assess how well the program is working. We are working on development of the teachers to help them with helping our students. With the analysis of test scores, students are getting a weekly segment to work specifically with what their needs are in order to help students learn at their own pace. Review of the Fine and Franklin coding program was very positive. It is very impressive to see the students that are very eager to participate in these programs. We anticipate incorporating the program at two more schools next year. We also have an elementary level enrichment program for our students that meets twice a month on Saturdays. We are exposing our students to CTE programs at an earlier grade so they can begin receiving information about the programs. We have hired a work based learning coordinator for our CTE programs in order to concentrate more on exposing our students to training and job search.
