**WHEREAS,** The Board of Education of the Township of Pennsauken, in the County of Camden, New Jersey ("School District"), has determined to undertake for lawful school purposes a capital project consisting of various improvements and renovations to the School District facilities ("Project"); and

**WHEREAS,** the Educational Facilities Construction and Financing Act ("Act") and other applicable law requires, as a condition precedent to undertaking the Project, the obtainment of various approvals by the School District; and

WHEREAS, the School District must issue its school bonds to finance the costs of the Project ("Bonds"); and

**WHEREAS**, the Project and the issuance of the Bonds must be approved by the voters of the School District ("Bond Referendum"); and

**WHEREAS,** it is the desire of the Board to authorize the appropriate School District officials and professional advisors to prepare and submit such applications and documents and to obtain such approvals as may be necessary to facilitate the Project and the Bond Referendum.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE TOWNSHIP OF PENNSAUKEN, IN THE COUNTY OF CAMDEN, NEW JERSEY, AS FOLLOWS:

- Section 1. In order to facilitate the Project and the Bond Referendum, the President of the Board, Vice President of the Board, Superintendent of Schools, Assistant Superintendent for Business/Board Secretary, other appropriate School District officials, together with the School District's Architect, Consulting Engineer, Financial Advisor, Solicitor, Bond Counsel and Auditor, are hereby authorized and directed to prepare and submit to the New Jersey Department of Education, the Pennsauken Township Planning Board and any other governmental agency, such applications, filings and documentation with respect to the Project and the Bond Referendum including, but not limited to, the concept plans and project application, as may be required under the Act and other applicable laws, and to represent the School District in matters pertaining thereto.

- **Section 4.** All resolutions, or parts thereof, inconsistent herewith are hereby repealed and rescinded to the extent of any such inconsistency.

**WHEREAS,** SBI and Pennsauken entered into a contract dated August 10, 2018, whereby SBI would be the General Contractor for Pennsauken and agreed to perform certain construction Work for the Pennsauken High School's Welding Shop Additional and Electrical Shop Renovation (referred to herein as the "Project") and Pennsauken agreed to pay SBI for such construction work to be payable in accordance with the terms of the Contract (referred to as "the Contract");

**WHEREAS**, Gaudelli and Straga entered into an April 23, 2018 subcontract to provide labor, materials, and equipment to construct the Project's HVAC work.

WHEREAS, various payment and workmanship disputes have arisen among the Parties hereto as set forth below;

**WHEREAS**, Pennsauken filed a Civil Complaint in the Camden County Superior Court against SBI on August 6, 2019 with Docket Number CAM-L-3161-19 (referred to herein as the "Complaint");

**WHEREAS,** Gaudelli impled a Third Party Complaint on July 15, 2010 against SBI and SBI's payment bond surety, North American Specialty Insurance Company ("Surety");

**WHEREAS**, on April 24, 2020 the parties went to mediation in an attempt to resolve the litigation, before the Honorable Francis J. Orlando (Retired); and

**WHEREAS**, the parties reached a tentative settlement whereby the Board will pay Straga Brothers Inc. One Hundred and Thirty Five Thousand Dollars (\$135,000.00) in resolution of all claims between the parties in accordance with Straga's Final Payment Application; and

**WHEREAS**, Board counsel has recommended that this settlement is in the best interests of the Board; therefore, be it:

**RESOLVED** that the Board of Education hereby approves the settlement of litigation with Straga Brothers Inc., with the Board paying Straga \$135,000.00, subject to the execution of a Release in a form acceptable to counsel and the Board.
