# RESOLUTION OF THE PENNSAUKEN TOWNSHIP BOARD OF EDUCATION APPROVING EMPLOYMENT CONTRACT FOR SUPERINTENDENT OF SCHOOLS RONNIE TARCHICHI

WHEREAS, the Board of Education of the Township of Pennsauken ("Board of Education") desires to hire Ronnie Tarchichi ("Tarchichi") as the Superintendent of Schools for the Pennsauken School District commencing on or before July 1, 2016; and,

**WHEREAS,** N.J.S.A. 18A:17-15 et. seq. requires that the Board of Education provide Tarchichi with a written Employment Agreement; and,

**WHEREAS**, the parties, through their respective counsel, have negotiated the terms and conditions of an Employment Agreement, with a term commencing on or before July 1, 2016 through June 30, 2020; and

**WHEREAS**, the Board of Education has submitted the Employment Agreement to the Camden County Executive County Superintendent of Schools, Dr. Lovell Pugh-Bassett for review and approval pursuant to N.J.S.A. 18A:7-8(j) and N.J.A.C. 6A:23A-3.1; and,

WHEREAS, approval of the Employment Agreement between the Board of Education and Tarchichi by ECS Pugh-Bassett has not yet been received by the Board of Education; and,

**WHEREAS,** in anticipation of receiving the approval of ECS Pugh-Bassett, the Board of Education desires to appoint, subject to the approval of ECS Pugh-Bassett, Tarchichi as the Superintendent of Schools for the Pennsauken School District; and,

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Education of the Township of Pennsauken as follows:

- 1. The Board of Education approves entering into an Employment Agreement with Ronnie Tarchichi for a period commencing on or before July 1, 2016 to June 30, 2020, subject to the final approval of the Employment Agreement by the Camden County Executive County Superintendent of Schools, Dr. Lovell Pugh-Bassett.
- 2. The Board of Education approves the appointment of Ronnie Tarchichi as Superintendent of Schools in accordance with said Agreement subject to the final approval of said Agreement by the Camden County Executive County Superintendent of Schools, Dr. Lovell Pugh-Bassett.
