WHEREAS, the School District is authorized by *N.J.S.A.* 18A:20-4.2 to purchase, take and condemn lands for school purposes within the district and lands needed for School District purposes, including the Project; and

WHEREAS, since the Project is not currently a part of the School District's Long Range Facility Plan, prepared in accordance with *N.J.S.A.* 18A:7G-4, in connection with any proposed acquisition of real property necessary for the Project, the School District will be required to obtain and submit certain information to the New Jersey Department of Education ("NJDOE") in order to appropriately authorize and approve the final acquisition of such real property; and

WHEREAS, in order to facilitate the Project, and the acquisition of real property necessary therefor, the Board is now desirous of authorizing and approving: (i) initiation of a comprehensive search for the purpose of locating a site upon which the Project will be constructed or included; (ii) the undertaking of negotiations for the acquisition of such site, if and when required; (iii) if necessary, obtaining the legal right to access the proposed site prior to the acquisition thereof; (iv) obtaining any additional information related to the proposed site of the Project necessary or required to make any filings with the NJDOE or as other may required by applicable law; (v) preparing and submitting an amendment to the School District's Long Range Facility Plan to include the Project; and (vi) submitting an offer on behalf of the School District should a site for the Project be identified; and (vii) delegating to certain Board and School District officials the authorization to undertake and complete any of the foregoing on behalf of the Board and the School District.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE TOWNSHIP OF PENNSAUKEN, IN THE COUNTY OF CAMDEN, NEW JERSEY, AS FOLLOWS:

Section 1. The Board hereby delegates to the Superintendent of Schools, the President of the Board and the Business Administrator/Board Secretary the authority to undertake and complete, and the same are hereby designated as "Authorized Officials" on behalf of the Board and the School District, certain actions in connection with the proposed Project including, but not limited to, the following: (i) initiating a comprehensive search for the purpose of locating a site upon which the Project will be constructed or included; (ii) undertaking negotiations for the acquisition of such site, if and when required; (iii) if necessary, obtaining the legal right to access the proposed site prior to the acquisition thereof; (iv) obtaining any additional information related to the proposed site of the Project necessary or required to make any filings with the NJDOE or as other may required by applicable law; (v) preparing and submitting an amendment to the School District's Long Range Facility Plan to include the Project; (vi) submitting an offer on behalf of the School District should a site for the Project be identified; and (vii) taking any other action necessary or required to accomplish the foregoing.

Section 2. The Authorized Officials, acting only in unison, are hereby authorized to submit an offer, on behalf of the School District, to the owner of a proposed Project site, and/or their agents or assigns, for the acquisition thereof; provided, however, that (i) prior to the submission of an offer therefor, the Authorized Officers shall have reported to the Board, the Board Solicitor and other designated professional advisors relevant details related to the proposed site of the Project and the purchase thereof, (ii) the Board shall have provided its consent for the submission of such offer for such site, and (iii) any and all final contracts for such acquisition shall be conditioned upon prior review and approval by the Board and the NJDOE.

Section 3. The Authorized Officers are each hereby severally authorized to determine all matters, prepare and submit all necessary filings with the NJDOE and any other relevant agencies or parties, including, but not limited to, an amendment to the School District's Long Range Facilities Plan, execute all documents and instruments in connection with the Project not determined or otherwise directed to be executed by applicable law, or by this or any subsequent resolution and to take any other action necessary in connection with the Project and the

signatures of the Authorized Officers on such documents or instruments shall be conclusive as to such determinations.

Section 4. All resolutions, or parts thereof, inconsistent herewith are hereby repealed and rescinded to

the extent of any such inconsistency.

Section 5. This resolution shall become effective immediately upon adoption this day of July,

2015.
